DIGEST OF INTRODUCED BILL

Citations Affected: IC 6-3-2-1.

Synopsis: Reduction of the individual income tax rate. For taxable years beginning after December 31, 2021, reduces the state individual adjusted gross income tax rate from 3.23% to 2.15%.

Effective: January 1, 2022 (retroactive).

| 38 | SECTION 2. An emergency is declared for this act. |
