DIGEST OF INTRODUCED BILL

Citations Affected: IC 35-31.5-2; IC 35-47.

Synopsis: Regulation of assault weapons. Prohibits a licensed importer, licensed manufacturer, licensed dealer, or licensed collector from selling or delivering a semiautomatic assault weapon to a person who is less than 21 years of age. Defines terms.
