DIGEST OF HB 1253 (Updated February 11, 2019 12:43 pm - DI 116)

Citations Affected: IC 5-2; IC 10-14; IC 10-21.

Synopsis: Handgun training for teachers. Creates a specialized firearms safety, education, and training curriculum (curriculum) for teachers, school staff, and school employees. Specifies curriculum requirements. Authorizes funds from the Indiana safe schools fund to be used for curriculum related expenses. Makes conforming amendments.

Effective: July 1, 2019.
