Synopsis: Magistrates in Scott County and Jefferson County. Allows the judges of the Jefferson County circuit and superior courts to appoint a magistrate to serve the Jefferson County courts. Allows the judges of the Scott County circuit and superior courts to appoint a magistrate to serve the Scott County courts.

Effective: July 1, 2018.

HOUSE BILL No. 1275

A BILL FOR AN ACT to amend the Indiana Code concerning courts and court officers.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 33-33-39-1, AS AMENDED BY P.L.127-2008,
2 SECTION 13, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2018]: Sec. 1. (a) Jefferson County constitutes the fifth
4 judicial circuit.

5 (b) **The judges of the Jefferson circuit court and Jefferson**
6 **superior court may jointly appoint one (1) full-time magistrate**
7 **under IC 33-23-5 to serve the circuit and superior courts.**

8 (c) **The magistrate continues in office until removed by the**
9 **judges of the Jefferson circuit and superior courts.**

10 SECTION 2. IC 33-33-72-1 IS AMENDED TO READ AS
11 FOLLOWS [EFFECTIVE JULY 1, 2018]: Sec. 1. (a) Scott County
12 constitutes the sixth judicial circuit.

13 (b) **The judges of the Scott circuit court and Scott superior court**
14 **may jointly appoint one (1) full-time magistrate under IC 33-23-5**
15 **to serve the circuit and superior courts.**

16 (c) **The magistrate continues in office until removed by the**
17 **judges of the Scott circuit and superior courts.**
