ENGROSSED HOUSE BILL No. 1287

DIGEST OF HB 1287 (Updated February 14, 2018 10:59 am - DI 84)

Citations Affected: IC 16-41.

Synopsis: Newborn screenings. Establishes when a blood sample must be taken from a newborn infant for testing for certain disorders. Provides that the time requirement for taking a blood sample does not apply to preterm infants or newborn infants who receive a total exchange blood transfusion.

Effective: July 1, 2018.

ENGROSSED HOUSE BILL No. 1287

A BILL FOR AN ACT to amend the Indiana Code concerning health.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 16-41-17-8 IS AMENDED TO READ AS
2 FOLLOWS [EFFECTIVE JULY 1, 2018]: Sec. 8. **(a)** Each hospital and
3 physician shall:
4 (1) **subject to subsection (b)**, take or cause to be taken a blood
5 sample from every infant born under the hospital's and physician's
6 care; and
7 (2) transport or cause to be transported each blood sample
8 described in subdivision (1) to a laboratory designated under
9 section 7 of this chapter;
10 for testing for the disorders listed in section 2(a) of this chapter.
11 **(b) This subsection does not apply to preterm infants or**
12 **newborn infants who receive a total exchange blood transfusion.**
13 **Except as provided in subsection (c), a newborn infant's blood**
14 **sample taken under subsection (a)(1) must be collected not earlier**
15 **than twenty-four (24) hours after birth.**
16 **(c) If a newborn infant is discharged before the time set forth in**
17 **subsection (b), the blood sample must be collected not earlier than**

- 1 **immediately before the infant's discharge, and a second blood**
- 2 **sample must be collected after forty-eight (48) hours but not later**
- 3 **than one hundred twenty (120) hours after birth.**
