HOUSE BILL No. 1295

DIGEST OF INTRODUCED BILL

Citations Affected: IC 25-1-9.7-2; IC 35-48-7-11.2.

Synopsis: Veterinary prescriptions. Limits an opioid prescription for an animal to a seven day supply unless a listed exception applies. Allows a veterinarian to obtain information about the owner of the animal or the individual to whom an opioid or benzodiazepine will be dispensed for the animal from the Indiana scheduled prescription electronic collection and tracking (INSPECT) program data base before prescribing an opioid or benzodiazepine for the animal.

Effective: July 1, 2019.

HOUSE BILL No. 1295

A BILL FOR AN ACT to amend the Indiana Code concerning professions and occupations.

Be it enacted by the General Assembly of the State of Indiana:

1	SECTION 1. IC 25-1-9.7-2, AS ADDED BY P.L.182-2017,
2	SECTION 1, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3	JULY 1, 2019]: Sec. 2. (a) Except as provided in subsection (b), a
4	prescriber may issue a prescription for an opioid only if the following
5	limitations are met:
6	(1) If the prescription is for an adult who is being prescribed an
7	opioid for the first time by the prescriber, the initial prescription
8	may not exceed a seven (7) day supply.
9	(2) If the prescription is for a child who is less than eighteen (18)
10	years of age, the prescription may not exceed a seven (7) day
11	supply.
12	(3) If the prescription is for an animal, the prescription may
13	not exceed a seven (7) day supply.
14	(b) The limitations set forth in subsection (a) do not apply under any
15	of the following circumstances:
16	(1) The prescriber is issuing the prescription for the treatment or
17	provision of any of the following:

1	(A) Cancer.
2	(B) Palliative care.
3	(C) Medication-assisted treatment for a substance use disorder.
4	(D) A condition that is adopted by rule by the medical
5	licensing board under IC 25-22.5-13-8 to be necessary to be

7	(2) If, in the professional judgment of a prescriber, a patient
8	requires more than the prescription limitations specified in
9	subsection (a).
10	(c) If a prescriber:
11	(1) determines that a drug other than an opioid is not appropriate;

13	(2) uses an exemption specified in subsection $(b)(1)(B)$ or $(b)(2)$
14	and issues a prescription for a patient that exceeds the limitations
15	set forth in subsection (a);
16	the prescriber shall document in the patient's medical record the
17	indication that a drug other than an opiate was not appropriate and that
18	the patient is receiving palliative care or that the prescriber is using the
19	prescriber's professional judgment for the exemption.
20	SECTION 2. IC 35-48-7-11.2 IS ADDED TO THE INDIANA
21	CODE AS A NEW SECTION TO READ AS FOLLOWS
22	[EFFECTIVE JULY 1, 2019]: Sec. 11.2. A practitioner who is a
23	veterinarian and who is treating an animal may obtain information
24	about:
25	(1) the owner of the animal; or
26	(2) the individual to whom an opioid or benzodiazepine will be
27	dispensed for the animal;
28	from the data base before prescribing an opioid or benzodiazepine
29	for the animal.
