## DIGEST OF INTRODUCED BILL

**Citations Affected:** IC 4-23-31-3.

**Synopsis:** Commission on the social status of black males. Changes the name of a member appointed to the commission on the social status of black males from superintendent of public instruction to secretary of education to recognize that after January 10, 2021, the position of chief executive officer of the department of education is transferred by law to the secretary of education appointed by the governor.

**Effective:** January 11, 2021 (retroactive).

# HOUSE BILL No. 1303

A BILL FOR AN ACT to amend the Indiana Code concerning state and local administration.

*Be it enacted by the General Assembly of the State of Indiana:*

1 SECTION 1. IC 4-23-31-3, AS ADDED BY P.L.133-2012,  
2 SECTION 29, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
3 JANUARY 11, 2021 (RETROACTIVE)]: Sec. 3. The commission  
4 consists of nineteen (19) members appointed as follows:  
5 (1) Two (2) members of the senate, who are not members of the  
6 same political party, appointed by the president pro tempore of  
7 the senate with the advice of the minority leader of the senate.  
8 (2) Two (2) members of the house of representatives, who are not  
9 members of the same political party, appointed by the speaker of  
10 the house of representatives with the advice of the minority leader  
11 of the house of representatives.  
12 (3) The director of the division of family resources or the  
13 director's designee.  
14 (4) The director of the division of mental health and addiction or  
15 the director's designee.  
16 (5) The commissioner of the state department of health or the  
17 commissioner's designee.



- 1 (6) The ~~superintendent secretary~~ of public instruction education  
2 or the ~~superintendent's secretary's~~ designee.  
3 (7) The commissioner of the department of correction or the  
4 commissioner's designee.  
5 (8) The director of the civil rights commission or the director's  
6 designee.  
7 (9) The commissioner of the Indiana department of administration  
8 or the commissioner's designee.  
9 (10) The lieutenant governor or the lieutenant governor's  
10 designee.  
11 (11) A minority business person, appointed by the governor.  
12 (12) Three (3) persons appointed by the president pro tempore of  
13 the senate who are not members of the general assembly. Not  
14 more than two (2) persons appointed under this subdivision may  
15 be members of the same political party.  
16 (13) Three (3) persons appointed by the speaker of the house of  
17 representatives who are not members of the general assembly. Not  
18 more than two (2) persons appointed under this subdivision may  
19 be members of the same political party.  
20 **SECTION 2. An emergency is declared for this act.**
