Synopsis: Gas and oil well assessment. Provides for the imposition of a monetary penalty against owners of oil or gas interests who fail to timely file a property schedule for gas and oil well assessments.

Effective: July 1, 2019.

HOUSE BILL No. 1305

A BILL FOR AN ACT to amend the Indiana Code concerning taxation.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 6-1.1-4-12.6, AS AMENDED BY P.L.146-2008,
2 SECTION 67, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2019]: Sec. 12.6. (a) For purposes of this section, the term
4 "secondary recovery method" includes but is not limited to the
5 stimulation of oil production by means of the injection of water, steam,
6 hydrocarbons, or chemicals, or by means of in situ combustion.
7 (b) The total assessed value of all interests in the oil located on or
8 beneath the surface of a particular tract of land equals the product of:
9 (1) the average daily production of the oil; multiplied by
10 (2) three hundred sixty-five (365); and multiplied by
11 (3) the posted price of oil on the assessment date.
12 However, if the oil is being extracted by use of a secondary recovery
13 method, the total assessed value of all interests in the oil equals
14 one-half (1/2) the assessed value computed under the formula
15 prescribed in this subsection. The appropriate township assessor (if
16 any), or the county assessor if there is no township assessor for the
17 township, shall, in the manner prescribed by the department of local

1 government finance, apportion the total assessed value of all interests
2 in the oil among the owners of those interests.

3 (c) The appropriate township assessor, or the county assessor if
4 there is no township assessor for the township, shall, in the manner
5 prescribed by the department of local government finance, determine
6 and apportion the total assessed value of all interests in the gas located
7 beneath the surface of a particular tract of land.

8 (d) The department of local government finance shall prescribe a
9 schedule for township and county assessors to use in assessing the **oil**
10 **or gas interests described in section 12.4(a) of this chapter and the**
11 **appurtenances described in section 12.4(c) of this chapter. The owner**
12 **or owner's agent of the oil or gas interests or appurtenances**
13 **described in section 12.4 of this chapter must file the schedule by**
14 **May 15 each year with the appropriate township assessor (if any),**
15 **or the county assessor if there is no township assessor for the**
16 **township.**

17 (e) **If a person fails to file the schedule required by subsection**
18 **(d) on or before the due date, the county auditor shall add a**
19 **penalty of twenty-five dollars (\$25) to the person's next property**
20 **tax installment. The county auditor shall also add an additional**
21 **penalty to the taxes payable by the person if the person fails to file**
22 **the schedule within thirty (30) days after the due date. The amount**
23 **of the additional penalty is twenty percent (20%) of the taxes**
24 **finally determined to be due with respect to the property which**
25 **should have been reported on the schedule.**



COMMITTEE REPORT

Mr. Speaker: Your Committee on Utilities, Energy and Telecommunications, to which was referred House Bill 1305, has had the same under consideration and begs leave to report the same back to the House with the recommendation that said bill be amended as follows:

Page 2, delete lines 17 through 25, begin a new paragraph and insert:

"(e) If a person fails to file the schedule required by subsection (d) on or before the due date, the county auditor shall add a penalty of twenty-five dollars (\$25) to the person's next property tax installment. The county auditor shall also add an additional penalty to the taxes payable by the person if the person fails to file the schedule within thirty (30) days after the due date. The amount of the additional penalty is twenty percent (20%) of the taxes finally determined to be due with respect to the property which should have been reported on the schedule."

and when so amended that said bill do pass.
