

HOUSE BILL No. 1310

DIGEST OF INTRODUCED BILL

Citations Affected: IC 25-22.5-1-2; IC 25-23-1-30.

Synopsis: Certified registered nurse anesthetist. Allows a certified registered nurse anesthetist to administer anesthesia under the direction of and in the immediate presence of a podiatrist if the administration takes place in a hospital and a licensed physician is available to respond immediately in person to a medical emergency.

Effective: July 1, 2015.

HOUSE BILL No. 1310



A BILL FOR AN ACT to amend the Indiana Code concerning professions and occupations.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 25-22.5-1-2, AS AMENDED BY P.L.232-2013,
2 SECTION 15, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2015]: Sec. 2. (a) This article, as it relates to the unlawful or
4 unauthorized practice of medicine or osteopathic medicine, does not
5 apply to any of the following:
6 (1) A student in training in a medical school approved by the
7 board, or while performing duties as an intern or a resident in a
8 hospital under the supervision of the hospital's staff or in a
9 program approved by the medical school.
10 (2) A person who renders service in case of emergency where no
11 fee or other consideration is contemplated, charged, or received.
12 (3) A paramedic (as defined in IC 16-18-2-266), an advanced
13 emergency medical technician (as defined in IC 16-18-2-6.5), an
14 emergency medical technician (as defined in IC 16-18-2-112), or
15 a person with equivalent certification from another state who



- 1 renders advanced life support (as defined in IC 16-18-2-7), or
 2 basic life support (as defined in IC 16-18-2-33.5):
 3 (A) during a disaster emergency declared by the governor
 4 under IC 10-14-3-12 in response to an act that the governor in
 5 good faith believes to be an act of terrorism (as defined in
 6 IC 35-31.5-2-329); and
 7 (B) in accordance with the rules adopted by the Indiana
 8 emergency medical services commission or the disaster
 9 emergency declaration of the governor.
 10 (4) Commissioned medical officers or medical service officers of
 11 the armed forces of the United States, the United States Public
 12 Health Service, and medical officers of the United States
 13 Department of Veterans Affairs in the discharge of their official
 14 duties in Indiana.
 15 (5) An individual who is not a licensee who resides in another
 16 state or country and is authorized to practice medicine or
 17 osteopathic medicine there, who is called in for consultation by an
 18 individual licensed to practice medicine or osteopathic medicine
 19 in Indiana.
 20 (6) A person administering a domestic or family remedy to a
 21 member of the person's family.
 22 (7) A member of a church practicing the religious tenets of the
 23 church if the member does not make a medical diagnosis,
 24 prescribe or administer drugs or medicines, perform surgical or
 25 physical operations, or assume the title of or profess to be a
 26 physician.
 27 (8) A school corporation and a school employee who acts under
 28 IC 34-30-14 (or IC 34-4-16.5-3.5 before its repeal).
 29 (9) A chiropractor practicing the chiropractor's profession under
 30 IC 25-10 or to an employee of a chiropractor acting under the
 31 direction and supervision of the chiropractor under IC 25-10-1-13.
 32 (10) A dental hygienist practicing the dental hygienist's profession
 33 under IC 25-13.
 34 (11) A dentist practicing the dentist's profession under IC 25-14.
 35 (12) A hearing aid dealer practicing the hearing aid dealer's
 36 profession under IC 25-20.
 37 (13) A nurse practicing the nurse's profession under IC 25-23.
 38 However, a certified registered nurse anesthetist (as defined in
 39 IC 25-23-1-1.4) may administer anesthesia if the certified
 40 registered nurse anesthetist ~~acts under the direction of and in the~~
 41 ~~immediate presence of a physician.~~ **meets the requirements set**
 42 **forth in IC 25-23-1-30.**



- 1 (14) An optometrist practicing the optometrist's profession under
 2 IC 25-24.
- 3 (15) A pharmacist practicing the pharmacist's profession under
 4 IC 25-26.
- 5 (16) A physical therapist practicing the physical therapist's
 6 profession under IC 25-27.
- 7 (17) A podiatrist practicing the podiatrist's profession under
 8 IC 25-29.
- 9 (18) A psychologist practicing the psychologist's profession under
 10 IC 25-33.
- 11 (19) A speech-language pathologist or audiologist practicing the
 12 pathologist's or audiologist's profession under IC 25-35.6.
- 13 (20) An employee of a physician or group of physicians who
 14 performs an act, a duty, or a function that is customarily within
 15 the specific area of practice of the employing physician or group
 16 of physicians, if the act, duty, or function is performed under the
 17 direction and supervision of the employing physician or a
 18 physician of the employing group within whose area of practice
 19 the act, duty, or function falls. An employee may not make a
 20 diagnosis or prescribe a treatment and must report the results of
 21 an examination of a patient conducted by the employee to the
 22 employing physician or the physician of the employing group
 23 under whose supervision the employee is working. An employee
 24 may not administer medication without the specific order of the
 25 employing physician or a physician of the employing group.
 26 Unless an employee is licensed or registered to independently
 27 practice in a profession described in subdivisions (9) through
 28 (18), nothing in this subsection grants the employee independent
 29 practitioner status or the authority to perform patient services in
 30 an independent practice in a profession.
- 31 (21) A hospital licensed under IC 16-21 or IC 12-25.
- 32 (22) A health care organization whose members, shareholders, or
 33 partners are individuals, partnerships, corporations, facilities, or
 34 institutions licensed or legally authorized by this state to provide
 35 health care or professional services as:
- 36 (A) a physician;
 37 (B) a psychiatric hospital;
 38 (C) a hospital;
 39 (D) a health maintenance organization or limited service
 40 health maintenance organization;
 41 (E) a health facility;
 42 (F) a dentist;



- 1 (G) a registered or licensed practical nurse;
 2 (H) a certified nurse midwife or a certified direct entry
 3 midwife;
 4 (I) an optometrist;
 5 (J) a podiatrist;
 6 (K) a chiropractor;
 7 (L) a physical therapist; or
 8 (M) a psychologist.
- 9 (23) A physician assistant practicing the physician assistant
 10 profession under IC 25-27.5.
- 11 (24) A physician providing medical treatment under section 2.1
 12 of this chapter.
- 13 (25) An attendant who provides attendant care services (as
 14 defined in IC 16-18-2-28.5).
- 15 (26) A personal services attendant providing authorized attendant
 16 care services under IC 12-10-17.1.
- 17 (27) A respiratory care practitioner practicing the practitioner's
 18 profession under IC 25-34.5.
- 19 (b) A person described in subsection (a)(9) through (a)(18) is not
 20 excluded from the application of this article if:
- 21 (1) the person performs an act that an Indiana statute does not
 22 authorize the person to perform; and
- 23 (2) the act qualifies in whole or in part as the practice of medicine
 24 or osteopathic medicine.
- 25 (c) An employment or other contractual relationship between an
 26 entity described in subsection (a)(21) through (a)(22) and a licensed
 27 physician does not constitute the unlawful practice of medicine under
 28 this article if the entity does not direct or control independent medical
 29 acts, decisions, or judgment of the licensed physician. However, if the
 30 direction or control is done by the entity under IC 34-30-15 (or
 31 IC 34-4-12.6 before its repeal), the entity is excluded from the
 32 application of this article as it relates to the unlawful practice of
 33 medicine or osteopathic medicine.
- 34 (d) This subsection does not apply to a prescription or drug order for
 35 a legend drug that is filled or refilled in a pharmacy owned or operated
 36 by a hospital licensed under IC 16-21. A physician licensed in Indiana
 37 who permits or authorizes a person to fill or refill a prescription or drug
 38 order for a legend drug except as authorized in IC 16-42-19-11 through
 39 IC 16-42-19-19 is subject to disciplinary action under IC 25-1-9. A
 40 person who violates this subsection commits the unlawful practice of
 41 medicine under this chapter.
- 42 (e) A person described in subsection (a)(8) shall not be authorized



1 to dispense contraceptives or birth control devices.
2 SECTION 2. IC 25-23-1-30, AS AMENDED BY P.L.177-2009,
3 SECTION 44, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
4 JULY 1, 2015]: Sec. 30. (a) A certified registered nurse anesthetist may
5 administer anesthesia if the certified registered nurse anesthetist acts
6 under the direction of and in the immediate presence of:
7 (1) a physician **licensed under IC 25-22.5; or**
8 (2) a **podiatrist licensed under IC 25-29, if:**
9 (A) **the administration of the anesthesia takes place in a**
10 **hospital; and**
11 (B) **a physician licensed under IC 25-22.5 is available to**
12 **respond immediately and in person to a medical**
13 **emergency.**
14 (b) Nothing in this chapter shall be construed as requiring a certified
15 registered nurse anesthetist to obtain prescriptive authority to
16 administer anesthesia under subsection (a).
