

HOUSE BILL No. 1310

DIGEST OF INTRODUCED BILL

Citations Affected: IC 2-3-10.

Synopsis: Drug testing for legislators. Requires the legislative council to establish and administer a program to test members of the general assembly for the use of controlled substances.

Effective: July 1, 2016.

HOUSE BILL No. 1310

A BILL FOR AN ACT to amend the Indiana Code concerning the general assembly.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 2-3-10 IS ADDED TO THE INDIANA CODE AS
2 A **NEW** CHAPTER TO READ AS FOLLOWS [EFFECTIVE JULY
3 1, 2016]:
4 **Chapter 10. Drug Testing for Legislators**
5 **Sec. 1. This chapter applies to a member of the general assembly**
6 **who:**
7 (1) **is serving in the general assembly on June 30, 2016; or**
8 (2) **is elected or appointed to the general assembly after June**
9 **30, 2016.**
10 **Sec. 2. As used in this chapter, "chamber" refers to either of the**
11 **following:**
12 (1) **The house of representatives.**
13 (2) **The senate.**
14 **Sec. 3. As used in this chapter, "controlled substance" has the**
15 **meaning set forth in IC 35-48-1-9.**
16 **Sec. 4. As used in this chapter, "legislative council" refers to the**
17 **legislative council created by IC 2-5-1.1-1.**



1 **Sec. 5. As used in this chapter, "member" refers to either of the**
2 **following:**

- 3 **(1) A member of the house of representatives.**
4 **(2) A member of the senate.**

5 **Sec. 6. As used in this chapter, "test negative" means that an**
6 **individual:**

- 7 **(1) tests negative for the presence of a controlled substance in**
8 **the individual's body; or**
9 **(2) tests positive for the presence of a controlled substance in**
10 **the individual's body but has:**
11 **(A) a valid prescription; or**
12 **(B) an order of a practitioner acting in the course of the**
13 **practitioner's professional practice;**
14 **for the controlled substance.**

15 **Sec. 7. As used in this chapter, "test positive" means an**
16 **individual:**

- 17 **(1) tests positive for the presence of a controlled substance in**
18 **the individual's body; and**
19 **(2) does not possess:**
20 **(A) a valid prescription; or**
21 **(B) an order of a practitioner acting in the course of the**
22 **practitioner's professional practice;**
23 **for the controlled substance.**

24 **Sec. 8. (a) The legislative council shall establish and administer**
25 **a program under this chapter to test for the presence of a**
26 **controlled substance in the body of a member.**

27 **(b) The program established under this section must:**

- 28 **(1) allow for a member to consent to random drug testing**
29 **described in subdivision (2) by signing a consent form**
30 **described in subsection (d);**
31 **(2) randomly administer a drug test to fifty percent (50%) of**
32 **the members who consent as described in subdivision (1)**
33 **during each regular legislative session of the general**
34 **assembly; and**
35 **(3) require drug testing of members who the:**
36 **(A) speaker of the house of representatives; or**
37 **(B) president pro tempore of the senate;**
38 **believes, based on reasonable suspicion, are engaged in the**
39 **illegal use of a controlled substance.**

40 **(c) If a member refuses to consent to random drug testing**
41 **described in subsection (b)(2), the member may not receive any of**
42 **the following privileges provided to members:**



- 1 (1) Partisan staff.
 2 (2) Franked mail.
 3 (3) Reserved parking at the statehouse.
 4 (4) Office space at the statehouse.
 5 (5) Electronic devices.
 6 (d) The consent form described in subsection (b)(1) must:
 7 (1) allow for a member to consent to random drug testing as
 8 described in subsection (b)(2); and
 9 (2) provide specific, detailed information concerning the
 10 privileges the member will not receive as provided under
 11 subsection (c) if the member does not consent to random drug
 12 testing.
 13 (e) A drug test administered under subsection (b)(2) or (b)(3)
 14 must be performed by a SAMHSA (as defined in IC 22-10-15-3)
 15 certified laboratory.
 16 Sec. 9. (a) The speaker of the house of representatives or
 17 president pro tempore of the senate is considered to have
 18 reasonable suspicion that a member is engaged in the illegal use of
 19 a controlled substance for purposes of section 8(b)(3) of this
 20 chapter if the member has been:
 21 (1) convicted of a crime; or
 22 (2) charged with an offense under IC 35-48 (controlled
 23 substances).
 24 (b) The speaker of the house of representatives and president
 25 pro tempore of the senate may determine that reasonable suspicion
 26 exists under section 8(b)(3) of this chapter from factors other than
 27 those listed in subsection (a).
 28 Sec. 10. A member shall submit to a drug test not later than
 29 twelve (12) hours after the member is notified that the member has
 30 been:
 31 (1) randomly selected for a drug test; or
 32 (2) selected for a drug test based on reasonable suspicion.
 33 Sec. 11. A member of the general assembly shall pay the costs of
 34 a drug test administered to the member under this chapter.
 35 Sec. 12. If:
 36 (1) a member who consented to random drug testing under
 37 this chapter refuses to take a drug test;
 38 (2) a member refuses to take a drug test based on reasonable
 39 suspicion as described in section 8(b)(3) of this chapter;
 40 (3) a member fails to take a drug test within the time required
 41 under section 10 of this chapter;
 42 (4) a member refuses to pay for a drug test as required under



- 1 section 11 of this chapter; or
2 (5) a finding is made by the member's chamber that the
3 member has tested positive on a drug test;
4 the member shall be assessed a penalty by the member's chamber
5 under the Constitution of the State of Indiana or the rules adopted
6 by the member's chamber, and the member loses all the privileges
7 listed in section 8(c) of this chapter provided to members.
8 **Sec. 13. The following lists shall be made available to the public:**
9 (1) The names of all the members who consent to random
10 drug testing under this chapter.
11 (2) The names of all the members who refuse to consent to
12 random drug testing under this chapter.
13 (3) The name of each member who is tested under this chapter
14 based on reasonable suspicion as described in section 8(b)(3)
15 of this chapter.
16 (4) The names of all the members who:
17 (A) test positive on a drug test administered under this
18 chapter; and
19 (B) test negative on a drug test administered under this
20 chapter.
