DIGEST OF HB 1317 (Updated February 21, 2017 9:23 am - DI 84)

**Citations Affected:** Noncode.

**Synopsis:** Vehicle inspection and maintenance program. Urges the legislative council to assign to the interim study committee on roads and transportation for study during the 2017 interim the topic of the motor vehicle inspection and maintenance program in Lake and Porter counties and whether there are alternatives to the program that would satisfy regulatory requirements and have a comparable effect on air quality.

## HOUSE BILL No. 1317

A BILL FOR AN ACT concerning transportation.

*Be it enacted by the General Assembly of the State of Indiana:*

1       SECTION 1. [EFFECTIVE JULY 1, 2017] (a) As used in this  
2       SECTION, "committee" refers to the interim study committee on  
3       roads and transportation established by IC 2-5-1.3-4(16).

4       (b) As used in this SECTION, "interim" has the meaning set  
5       forth in IC 2-5-1.3-1.

6       (c) As used in this SECTION, "legislative council" refers to the  
7       legislative council created by IC 2-5-1.1-1.

8       (d) The legislative council is urged to assign to the committee for  
9       study during the 2017 interim the topic of the motor vehicle  
10      inspection and maintenance program in Lake and Porter counties  
11      and whether there are alternatives to the program that would  
12      satisfy regulatory requirements and have a comparable effect on  
13      air quality.

14      (e) If the topic set forth in subsection (d) is assigned to the  
15      committee, the committee shall issue a final report to the legislative  
16      council containing the committee's findings and recommendations  
17      in an electronic format under IC 5-14-6 not later than November  
18      1, 2017.
