## **HOUSE BILL No. 1320**

#### DIGEST OF INTRODUCED BILL

**Citations Affected:** IC 20-18-2-16; IC 20-33-7.5.

**Synopsis:** Student records. Requires the state board of education to establish a statewide student record repository of public school student achievement records to provide: (1) access to relevant student records to parents and school corporations; (2) for the transfer of student records between school corporations; and (3) a student data backup for school corporations.

Effective: July 1, 2014.

### **HOUSE BILL No. 1320**

A BILL FOR AN ACT to amend the Indiana Code concerning education.

Be it enacted by the General Assembly of the State of Indiana:

11	SECTION 2. IC 20-33-7.5 IS ADDED TO THE INDIANA CODE

14	Chapter 7.5. Access to Student Records
15	Sec. 1. As used in this chapter, "authorized user" means a
16	teacher or other person who is:
17	(1) employed by a school corporation; and
18	(2) authorized to access data in a student achievement record
19	through the student record repository.
20	Sec. 2. As used in this chapter, "school corporation" includes a
21	public school corporation, a charter school, the Indiana School for
22	the Blind and Visually Impaired, and the Indiana School for the
23	Deaf.
24	Sec. 3. As used in this chapter, "student achievement record"
25	means a complete profile of learning for a student in kindergarten
26	through grade 12 that:
27	(1) is in an electronic format;
28	(2) contains student records from each grade and each school
29	the student attends; and
30	(3) is accessible by the student's parent or an authorized user.
31	Sec. 4. As used in this chapter, "student record repository"
32	refers to the data bank of student data collected from school
33	corporations as a part of the state's longitudinal data system that
34	is managed by the department and is accessible to authorized users
35	through an Internet browser.
36	Sec. 5. (a) The state board shall use a comprehensive data
37	collection system that is maintained by the department and collects
38	longitudinal student transcript data with unique student identifiers
39	from school corporations to allow access to a student's achievement
40	record by the following:

2	(b) The state board shall ensure that a student achievement
3	record:
4	(1) provides a uniform, transparent reporting mechanism for
5	individual student progress;
6	(2) provides a complete student history for postsecondary
7	planning;
8	(3) provides a teacher with information about a student's
9	complete profile to better inform instruction and individualize
10	education;
11	(4) assists a teacher or an administrator in ascertaining a
12	student's learning needs through the use of data already
13	collected;
14	(5) facilitates a student's parent's ability to take an active role
15	in the student's education by simplifying access to the
16	student's achievement record; and
17	(6) serves as a data backup for a school corporation as part of
18	the school corporation's disaster recovery plan.
19	Sec. 6. Using existing data collected and maintained in the
20	comprehensive data collection system by the department, the state
21	board shall create the student record repository, from which ar
22	authorized user may:
23	(1) access data in a student achievement record that is
24	relevant to the authorized user's school corporation or a
25	school within the school corporation; or
26	(2) request student records to be transferred from one (1)
27	school corporation to another school corporation.
28	Sec. 7. The state board shall implement security measures to
29	ensure that:
30	(1) student data stored in or transmitted to or from the
31	student record repository is secure and confidential as
32	required under the Family Educational Rights and Privacy
33	Act, 20 U.S.C. 1232g; and
34	(2) an authorized user may access only student data that is
35	relevant to the authorized user's school corporation or school
36	Sec. 8. (a) Not later than June 30, 2015, the state board shal
37	ensure that an authorized user is able to access or request to
38	transfer from one (1) school corporation to another school
39	corporation the following data from a student's achievement
40	record:
41	(1) Student demographics.
42	(2) Course grades.

2	(4) ISTEP assessment results.
3	(b) Not later than June 30, 2015, the state board shall ensure
4	that an authorized user is able to access or request to transfer from
5	one (1) school corporation to another school corporation the
6	following data from a student's achievement record in addition to
7	the student data set forth in subsection (a):
8	(1) Attendance.
9	(2) The name and qualifications, including years of
10	experience, degree, license, and endorsements, of the student's
11	teacher for each class or course the student takes.
12	(3) Results of any formative, interim, and summative
13	computer adaptive assessments administered to the student.
14	(4) Detailed data demonstrating the student's mastery of core
15	standards and objectives as measured by computer adaptive
16	assessments.
17	(5) The student's writing sample written for an online writing
18	assessment.
19	(6) A student's growth score from the ISTEP assessment.
20	(7) The category or designation under IC 20-31-8 in which the
21	school the student attends is placed.
22	(8) The student's reading level at the end of grade 3.
23	(c) Not later than June 30, 2017, the state board shall ensure
24	that the data stored in the student record repository for a school
25	corporation's student achievement records are:
26	(1) integrated with the school corporation's student
27	information system; and
28	(2) available to a student's parent and an authorized user in
29	an easily accessible viewing format.
30	Sec. 9. A student's parent may request the student's
31	achievement record from the school corporation or school in which
32	the student is enrolled.
33	Sec. 10. The state board shall adopt rules under IC 4-22-2 to
34	carry out this chapter.
