DIGEST OF HB 1335 (Updated January 22, 2014 4:11 pm - DI 97)

Citations Affected: Noncode.

Synopsis: High cost management study. Urges the legislative council to assign to an interim study committee for study during the 2014 interim the topic of implementation of a high cost management program for individuals who incur more than \$1,500,000 in health care costs due to a chronic disease or injury.

Effective: July 1, 2014.

HOUSE BILL No. 1335

A BILL FOR AN ACT concerning insurance.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. [EFFECTIVE JULY 1, 2014] (a) **The definitions in**
2 **IC 27-19-2 apply throughout this SECTION.**
3 (b) **The legislative council is urged to assign to an appropriate**
4 **interim study committee for study during the 2014 interim of the**
5 **general assembly the topic of implementation of a high cost**
6 **management program through which:**
7 (1) **a health plan offered to a person in Indiana contains a**
8 **provision by which an individual who:**
9 (A) **is entitled to coverage under the health plan; and**
10 (B) **incurs more than one million five hundred thousand**
11 **dollars (\$1,500,000) in lifetime claim costs due to a chronic**
12 **disease or an injury;**
13 **must participate in a high cost management program**
14 **implemented under subdivision (2) as a condition of coverage**
15 **(including coverage for essential health benefits) under the**
16 **health plan;**
17 (2) **the department, in consultation with appropriate state**

1 agencies, implements high cost management programs that:
2 (A) are approved by the department based on a review of
3 chronic disease, injury, and pharmaceutical management
4 programs used in populations similar to the individual;
5 (B) are determined to be expected to best improve health
6 outcomes in a cost effective manner; and
7 (C) include the use of recognized experts in the treatment
8 of the applicable chronic disease or injury; and
9 (3) state funding, in an amount not to exceed ten percent
10 (10%) of the individual's claim costs described in subdivision
11 (1), is applied to coverage of claim costs incurred by the
12 individual that are paid by the health plan toward treatment
13 that is provided through the high cost management program
14 in which the individual participates;
15 or a similar high cost management program.
16 (c) This SECTION expires January 1, 2015.

Page 1, line 1, delete "IC 27-8-5-30 IS ADDED TO THE INDIANA CODE".

Page 1, delete line 2.

Page 1, line 3, delete "1, 2014]: Sec. 30." and insert "[EFFECTIVE JULY 1, 2014]".

Page 1, line 4, delete "section." and insert "**SECTION.**".

Page 1, delete lines 5 through 6, begin a new paragraph and insert:

"(b) The legislative council is urged to assign to an appropriate interim study committee for study during the 2014 interim of the general assembly the topic of implementation of a high".

Page 2, line 16, delete "." and insert ";

or a similar high cost management program.

(c) This SECTION expires January 1, 2015."

and when so amended that said bill do pass.
