Synopsis: Repayment of federal student loans. Establishes the Indiana resident federal student loan repayment program and fund. Requires the commission for higher education to administer the program. Establishes requirements to qualify for federal student loan repayment assistance.

(a) The Indiana resident federal student loan repayment 2 fund is established for the purpose of providing funds to repay 3 outstanding federal student loans of residents of Indiana who meet 4 the requirements under section 5 of this chapter. 5 (b) The fund consists of the following: 6 (1) Appropriations made by the general assembly. 7 (2) Gifts, grants, devises, or bequests made to the commission 8 to achieve the purposes of the fund. 9 (c) The commission shall administer the fund. 10 (d) The expenses of administering the fund shall be paid from 11 money in the fund. 12 (e) The treasurer of state shall invest the money in the fund not 13 currently needed to meet the obligations of the fund in the same 14 manner as other public funds may be invested. Interest that 15 accrues from these investments shall be deposited in the fund. 16 (f) Money in the fund at the end of a state fiscal year does not 17 revert to the state general fund but remains available to be used for 18 the purposes of this chapter. 19 Sec. 5. Beginning after June 30, 2023, an applicant who meets 20 the requirements under this chapter may qualify for federal 21 student loan repayment assistance under this chapter. To qualify 22 for federal student loan repayment assistance under this chapter, 23 an applicant must meet the following conditions: 24 (1) Have applied for federal student loan repayment 25 assistance on a form supplied by the commission. 26 (2) Have graduated with a baccalaureate degree from a state 27 educational institution. 28 (3) Have an outstanding federal student loan balance. 29 (4) Have resided continuously in Indiana after graduating 30 from the state educational institution described in subdivision 31 (2) for at least the following: 32 (A) To receive federal student loan repayment assistance 33 under section 6(a)(1) of this chapter, two (2) years. 34 (B) To receive federal student loan repayment assistance 35 under section 6(a)(2) of this chapter, five (5) years. 36 (5) Any other criteria established by the commission. 37 Sec. 6. (a) If an applicant meets the requirements and is 38 awarded assistance under this chapter, the federal student loan 39 repayment assistance awarded under this chapter is equal to the 40 following: 41 (1) For an applicant who has resided continuously in Indiana 42 for at least two (2) years but less than five (5) years after

1 graduating from a state educational institution with a 2 baccalaureate degree as described in section 5(2) of this 3 chapter, fifty percent (50%) of the balance of the federal 4 student loan amount that the applicant incurred to obtain the 5 baccalaureate degree from the state educational institution. 6 (2) For an applicant who has resided continuously in Indiana 7 for at least five (5) years after graduating from a state 8 educational institution with a baccalaureate degree as 9 described in section 5(2) of this chapter, the balance of the 10 federal student loan amount that the applicant incurred to 11 obtain the baccalaureate degree from the state educational 12 institution. 13 (b) An applicant may be awarded federal student loan 14 repayment assistance under this chapter for federal student loans 15 incurred by the applicant to obtain one (1) baccalaureate degree. 16 Federal student loan repayment assistance may not be awarded for 17 any subsequent or additional baccalaureate degrees that the 18 applicant obtains. 19 (c) One (1) applicant may apply for and be awarded federal 20 student loan repayment assistance under subsection (a)(1) and 21 (a)(2). 22 Sec. 7. Each individual who: 23 (1) applies under this chapter; and 24 (2) is approved under this chapter; 25 shall provide to the commission any information that the 26 commission determines is necessary to administer this chapter. 27 Sec. 8. The commission: 28 (1) shall adopt rules under IC 4-22-2 that are necessary to 29 ensure that federal student loan repayment assistance 30 awarded under this chapter is used for the repayment of an 31 eligible applicant's federal student loans, including entering 32 into agreements as necessary; and 33 (2) may adopt rules under IC 4-22-2 that are necessary to 34 implement this chapter.
