HOUSE BILL No. 1342

DIGEST OF HB 1342 (Updated February 9, 2023 4:30 pm - DI 148)

Citations Affected: IC 12-7; IC 12-11.

Synopsis: Direct support professionals. Requires the division of disability and rehabilitative services (division) to establish and maintain a direct support professional registry and to make the registry available to authorized division personnel and authorized service providers. Requires a direct support professional to register with the division in order to provide direct support services. Requires the division to adopt rules to implement the registry, including establishing definitions and levels for substantiated abuse, neglect, and exploitation, the highest of which is the minimum the division must report to the registry. Requires the division to consult with stakeholders and establish a tiered training certification program for direct support professionals. Requires the division to issue a request for proposals before January 1, 2024, to operate the training program. Requires the division to contract with a vendor for the training program not later than January 1, 2025. Allows the division to use any federal dollars available for the registry and training. Requires the division to apply to the federal government for approval of Medicaid reimbursement for services provided by a direct support professional.

Effective: Upon passage.

HOUSE BILL No. 1342

A BILL FOR AN ACT to amend the Indiana Code concerning human services.

Be it enacted by the General Assembly of the State of Indiana:

1	SECTION 1. IC 12-7-2-63.5 IS ADDED TO THE INDIANA CODE
2	AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE
3	UPON PASSAGE]: Sec. 63.5. "Direct support professional", for
4	purposes of IC 12-11-16, has the meaning set forth in
5	IC 12-11-16-1.
6	SECTION 2. IC 12-11-16 IS ADDED TO THE INDIANA CODE
7	AS A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE
8	UPON PASSAGE]:
9	Chapter 16. Direct Support Professional Registry and Training
10	Sec. 1. As used in this chapter, "direct support professional"
11	means an individual who:
12	(1) is employed by an authorized service provider;
13	(2) is paid on an hourly basis; and
14	(3) is defined in 460 IAC 6-3-18 (as in effect on January 1,
15	2023) or 460 IAC 9-1-18 (as in effect on January 1, 2023).
16	Sec. 2. (a) The division shall establish and maintain a direct
17	support professional registry to be made available to authorized



1	division personnel and authorized service providers. The registry
2	must:
3	(1) include a list of direct support professionals who have
4	registered with the division in the manner required by the
5	division; and
6	(2) contain any substantiated incidents for abuse, neglect, and
7	exploitation that meet the criteria established according to
8	subsection (d), as determined by the division for a direct
9	support professional included on the registry.
10	(b) The division shall establish the following:
11	(1) An application to be used for an individual to register for
12	the registry and renew the registration for the registry.
13	(2) An appeals process as provided in IC 4-21.5 concerning an
14	incident involving a direct support professional in which the
15	division has determined the incident meets the criteria
16	established according to subsection (d).
17	(c) Beginning January 1, 2025, and thereafter, an individual
18	may not provide direct support services as a direct support
19	professional in Indiana unless the individual is registered by the
20	division for the registry under this chapter.
21	(d) The division shall adopt rules under IC 4-22-2 necessary to
22	implement the registry, including the establishment of definitions
23	and levels for substantiated abuse, neglect, and exploitation, the
24	highest of which is the minimum the division must report to the
25	registry.
26	(e) The division shall report to the registry a substantiated
27	incident that meets the criteria established according to subsection
28	(d).
29	Sec. 3. (a) The division shall consult with stakeholders who do
30	not have a conflict of interest to do the following:
31	(1) Establish standards of a competency based training
32	curriculum for direct support professionals.
33	(2) Develop procedures to improve incident reporting
34	concerning direct support professionals.
35	(b) The training curriculum established under this section must
36	include a tiered approach to training that consists of the following:
37	(1) General education and training in providing direct
38	support to individuals with intellectual disabilities or
39	developmental disabilities with the issuance of a certificate
40	upon successful completion of a standardized test.
41	(2) Specialized subcategories of additional direct support
42	professional training to allow for advanced learning and



1	enable career growth in the provision of direct support
2	services.
3	Sec. 4. (a) Before January 1, 2024, the division shall issue a
4	request for proposals in compliance with IC 5-22-9 seeking bids to
5	operate the training program with the established standards
6	determined under section 3 of this chapter.
7	(b) The division shall make every effort to contract with a
8	vendor from the request for proposals issued under subsection (a)
9	not later than January 1, 2025.
10	Sec. 5. The division may use any federal dollars available for the
11	implementation of this chapter.
12	Sec. 6. (a) Before August 31, 2024, the office of the secretary
13	shall apply to the United States Department of Health and Human
14	Services for any Medicaid waiver necessary to allow for Medicaid
15	reimbursement for Medicaid waiver covered services provided to
16	a Medicaid waiver recipient by a registered direct support
17	professional when training described in section 3(b)(1) of this
18	chapter:
19	(1) is being conducted, but has not been completed; and
20	(2) has been completed;
21	by the direct support professional.
22	(b) This section expires December 31, 2024.
23	SECTION 3. An emergency is declared for this act.



COMMITTEE REPORT

Mr. Speaker: Your Committee on Family, Children and Human Affairs, to which was referred House Bill 1342, has had the same under consideration and begs leave to report the same back to the House with the recommendation that said bill be amended as follows:

Page 1, line 14, delete "provides any of the following support services:" and insert "is defined in 460 IAC 6-3-18 (as in effect on January 1, 2023) or 460 IAC 9-1-18 (as in effect on January 1, 2023).".

Page 1, delete lines 15 through 17.

Page 2, delete lines 1 through 16.

Page 2, line 18, delete "for direct support professionals." and insert "to be made available to authorized division personnel and authorized service providers.".

Page 2, line 23, delete "complaints" and insert "incidents".

Page 2, line 24, delete "exploitation," and insert "**exploitation that meet the criteria established according to subsection (d),**".

Page 2, delete lines 29 through 30.

Page 2, line 31, delete "(3)" and insert "(2)".

Page 2, line 31, delete "concerning a" and insert "concerning an".

Page 2, line 32, delete "complaint in" and insert "**incident involving** a direct support professional in".

Page 2, line 32, delete "the complaint" and insert "the incident meets the criteria established according to subsection (d).".

Page 2, delete line 33.

Page 2, line 38, delete "may" and insert "shall".

Page 2, line 39, delete "registry and complaint investigation procedure." and insert "registry, including the establishment of definitions and levels for substantiated abuse, neglect, and exploitation, the highest of which is the minimum the division must report to the registry.".

Page 2, between lines 39 and 40, begin a new paragraph and insert:

"(e) The division shall report to the registry a substantiated incident that meets the criteria established according to subsection (d).".

Page 3, line 20, delete "July 1, 2024." and insert "January 1, 2025.".

Page 3, line 23, delete "August 30, 2023," and insert "August 31, 2024,".

Page 3, line 33, delete "December 31, 2023." and insert "**December** 31, 2024.".
