

HOUSE BILL No. 1346

DIGEST OF INTRODUCED BILL

Citations Affected: IC 36-8-16.7-47.5.

Synopsis: Public service answering point governance. Provides that after June 30, 2018, in a county: (1) in which 911 service is provided countywide by one public service answering point (PSAP); and (2) that contains a municipality, the population of which exceeds the population of the county if the municipality's population is excluded from the population of the county; the majority of members constituting the board or other governing body of the PSAP must consist of an even number of representatives of the municipality, half of which shall be appointed by the executive of the municipality, and half of which shall be appointed by the legislative body of the municipality.

Effective: Upon passage.

HOUSE BILL No. 1346

A BILL FOR AN ACT to amend the Indiana Code concerning local government.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 36-8-16.7-47.5 IS ADDED TO THE INDIANA
2 CODE AS A **NEW** SECTION TO READ AS FOLLOWS
3 [EFFECTIVE UPON PASSAGE]: **Sec. 47.5. (a) This section applies**
4 **to a county:**
5 (1) **in which 911 service is provided throughout the county by**
6 **one (1) PSAP; and**
7 (2) **that contains a municipality, the population of which**
8 **exceeds the population of the county if the municipality's**
9 **population is excluded from the population of the county.**
10 (b) **After June 30, 2018, in a county to which this section applies,**
11 **the majority of members constituting the board or other governing**
12 **body of the PSAP described in subsection (a)(1) must consist of an**
13 **even number of representatives of the municipality described in**
14 **subsection (a)(2), half of which shall be appointed by the executive**
15 **of the municipality, and half of which shall be appointed by the**
16 **legislative body of the municipality.**
17 (c) **If before July 1, 2018, in a county to which this section**



1 applies, the membership of the board or other governing body of
2 the PSAP described in subsection (a)(1) does not conform to the
3 membership set forth in subsection (b):
4 (1) the total number of members on the board or other
5 governing body may be increased or decreased; or
6 (2) the composition of the board or other governing body may
7 be otherwise changed;
8 as necessary to ensure that the membership of the board or other
9 governing body of the PSAP conforms to the membership set forth
10 in subsection (b) not later than July 1, 2018.
11 SECTION 2. An emergency is declared for this act.
