DIGEST OF HB 1354 (Updated February 21, 2022 11:08 am - DI 148)

Citations Affected: Noncode.

Synopsis: Requirements for SNAP participants. Urges the legislative council to assign to an interim study committee the following topics: (1) Requiring the custodial and noncustodial parents to cooperate with the child support bureau as a condition of eligibility for assistance under the Supplemental Nutrition Assistance Program (SNAP). (2) Assigning individuals who are subject to federal work requirements for SNAP eligibility to an employment and training program.

Effective: Upon passage.

8 **requirements established under 7 U.S.C. 2015(d)(1) to an**
9 **employment and training program (as defined in 7 U.S.C.**
10 **2015(d)(4)(B)).**
11 **(b) This SECTION expires January 1, 2023.**
12 SECTION 2. **An emergency is declared for this act.**
