

HOUSE BILL No. 1363

DIGEST OF INTRODUCED BILL

Citations Affected: IC 20-30-2; IC 20-43-3-4.

Synopsis: School calendar. Requires, beginning with the 2017-2018 school year, a school corporation to conduct at least 175 student instructional days in a school year. (Currently, a school corporation is required to conduct at least 180 student instructional days.) Provides, beginning with the 2017-2018 school year, that student instructional days begin the Tuesday after Labor Day (the first Monday in September) and end the Friday before Memorial Day (the last Monday in May). Repeals sections concerning a penalty for conducting fewer than 180, but more than 175, student instructional days and deletes a reference to one of those sections in the tuition support calculations.

Effective: July 1, 2016.

HOUSE BILL No. 1363

A BILL FOR AN ACT to amend the Indiana Code concerning education.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 20-30-2-3, AS ADDED BY P.L.1-2005, SECTION
2 14, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1,
3 2016]: Sec. 3. **(a)** For each school year, a school corporation shall
4 conduct at least one hundred eighty (180) student instructional days.
5 Not later than June 15 of each school year, the superintendent of each
6 school corporation shall certify to the department the number of student
7 instructional days conducted during that school year.

8 **(b) Beginning with the 2017-2018 school year, for each school**
9 **year, a school corporation shall conduct at least one hundred**
10 **seventy-five (175) student instructional days. Not later than June**
11 **15 of each school year, the superintendent of each school**
12 **corporation shall certify to the department the number of student**
13 **instructional days conducted during that school year.**

14 SECTION 2. IC 20-30-2-3.5 IS ADDED TO THE INDIANA CODE
15 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
16 1, 2016]: Sec. 3.5. **(a) This section applies only to a collective**
17 **bargaining agreement between a school employer (as defined in**



1 IC 20-29-2-15) and an exclusive representative that goes into effect
2 after June 30, 2017.

3 (b) This section applies only to a contract entered into or
4 renewed by a governing body that goes into effect after June 30,
5 2017.

6 (c) This section does not apply to a nonpublic school.

7 (d) Beginning with the 2017-2018 school year, the student
8 instructional days that make up a school year shall:

9 (1) begin the Tuesday after Labor Day, the first Monday in
10 September; and

11 (2) end the Friday before Memorial Day, the last Monday in
12 May, of the following year.

13 SECTION 3. IC 20-30-2-4 IS REPEALED [EFFECTIVE JULY 1,
14 2016]. Sec. 4: If a school corporation fails to conduct the minimum
15 number of student instructional days during a school year as required
16 under section 3 of this chapter, the department shall reduce the August
17 tuition support distribution to that school corporation for a school year
18 by an amount determined as follows:

19 STEP ONE: Determine the remainder of:

20 (A) the amount of the total tuition support allocated to the
21 school corporation for the particular school year; minus

22 (B) that part of the total tuition support allocated to the school
23 corporation for that school year with respect to student
24 instructional days one hundred seventy-six (176) through one
25 hundred eighty (180):

26 STEP TWO: Subtract the number of student instructional days
27 that the school corporation conducted from one hundred eighty
28 (180):

29 STEP THREE: Determine the lesser of five (5) or the remainder
30 determined under STEP TWO:

31 STEP FOUR: Divide the amount subtracted under STEP ONE(B)
32 by five (5):

33 STEP FIVE: Multiply the quotient determined under STEP FOUR
34 by the number determined under STEP THREE:

35 STEP SIX: Subtract the number determined under STEP THREE
36 from the remainder determined under STEP TWO:

37 STEP SEVEN: Divide the remainder determined under STEP
38 ONE by one hundred seventy-five (175):

39 STEP EIGHT: Multiply the quotient determined under STEP
40 SEVEN by the remainder determined under STEP SIX:

41 STEP NINE: Add the product determined under STEP FIVE to
42 the product determined under STEP EIGHT.



1 SECTION 4. IC 20-30-2-5 IS REPEALED [EFFECTIVE JULY 1,
2 2016]. Sec. 5: The department may grant a waiver of the penalty
3 imposed under section 4 of this chapter for a particular number of
4 canceled student instructional days if:

- 5 (1) the school corporation applies to the department for a waiver
6 of the penalty imposed under section 4 of this chapter for a
7 specific number of canceled student instructional days; and
8 (2) each of the particular number of student instructional days
9 requested to be waived under this section was canceled due to
10 extraordinary circumstances:

11 SECTION 5. IC 20-30-2-6 IS REPEALED [EFFECTIVE JULY 1,
12 2016]. Sec. 6: The department shall develop guidelines for school
13 corporations to apply for a waiver under section 5 of this chapter:

14 SECTION 6. IC 20-43-3-4, AS AMENDED BY P.L.213-2015,
15 SECTION 211, IS AMENDED TO READ AS FOLLOWS
16 [EFFECTIVE JULY 1, 2016]: Sec. 4. (a) This subsection applies to the
17 determination of a school corporation's previous year's revenue for
18 purposes of determining distributions under this article. A school
19 corporation's previous year revenue equals the amount determined
20 using the following formula:

21 STEP ONE: Determine the school corporation's basic tuition
22 support actually received for the state fiscal year that immediately
23 precedes the current state fiscal year.

24 STEP TWO: Subtract from the STEP ONE result an amount equal
25 to the reduction in the school corporation's state tuition support
26 under any combination of subsection (b). ~~or IC 20-30-2-4.~~

27 (b) A school corporation's previous year revenue must be reduced
28 if:

- 29 (1) the school corporation's state tuition support for special
30 education or career and technical education is reduced as a result
31 of a complaint being filed with the department after December 31,
32 1988, because the school program overstated the number of
33 children enrolled in special education programs or career and
34 technical education programs; and
35 (2) the school corporation's previous year revenue has not been
36 reduced under this subsection more than one (1) time because of
37 a given overstatement.

38 The amount of the reduction equals the amount the school corporation
39 would have received in state tuition support for special education and
40 career and technical education because of the overstatement.
