

HOUSE BILL No. 1372

DIGEST OF HB 1372 (Updated February 8, 2021 1:15 pm - DI 143)

Citations Affected: IC 12-26.

Synopsis: Emergency transport. Provides that a political subdivision employing a police officer who transports an individual may bill the individual or the individual's responsible party for the transportation. Requires the collected funds to be deposited in the political subdivision's general fund.

Effective: July 1, 2021.

HOUSE BILL No. 1372

A BILL FOR AN ACT to amend the Indiana Code concerning human services.

Be it enacted by the General Assembly of the State of Indiana:

- SECTION 1. IC 12-26-5-2 IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2021]: Sec. 2. (a) If a judicial officer authorized to issue a warrant for arrest in the county in which the individual is present endorses an application made under section 1 of this chapter, the application authorizes a police officer to take the individual into custody and transport the individual to a facility.
- (b) Except as provided in subsection (c), the expense of transportation under this section shall be paid by the county in which the individual is present.
- (c) The political subdivision employing a police officer who transports an individual under subsection (a) may bill the individual or the individual's responsible party for the transportation provided in subsection (a). Any funds collected from billing under this section must be deposited in the general fund of the political subdivision.
