DIGEST OF HB 1372 (Updated March 25, 2021 10:53 am - DI 87)

Citations Affected: IC 12-26.

Synopsis: Emergency transport. Provides that the county sheriff may receive reimbursement from a nonincarcerated person's health coverage for providing nonemergency transport of the person to a facility for a mental health detention.

Effective: July 1, 2021.

ENGROSSED HOUSE BILL No. 1372

A BILL FOR AN ACT to amend the Indiana Code concerning human services.

Be it enacted by the General Assembly of the State of Indiana:

1	SECTION 1. IC 12-26-5-2 IS AMENDED TO READ AS
2	FOLLOWS [EFFECTIVE JULY 1, 2021]: Sec. 2. (a) If a judicial
3	officer authorized to issue a warrant for arrest in the county in which
4	the individual is present endorses an application made under section 1
5	of this chapter, the application authorizes a police officer to take the
6	individual into custody and transport the individual to a facility.
7	(b) Except as provided in subsection (c), the expense of
8	transportation under this section shall be paid by the county in which
9	the individual is present.
10	(c) This subsection applies only to the nonemergency transport
11	to a facility by the county sheriff or deputy sheriff of an individual
12	who:
13	(1) is not in lawful detention (as defined in IC 36-2-13-18);
14	(2) has had an application for the individual's detention under
15	section 1 of this chapter endorsed by a judicial officer; and
16	(3) is transported more than thirty (30) miles.
17	The county sheriff may be reimbursed from the individual's health

Page 1, delete lines 10 through 17, begin a new paragraph and insert:

"(c) The political subdivision employing a police officer who transports an individual under subsection (a) may bill the individual or the individual's responsible party for the transportation provided in subsection (a). Any funds collected from billing under this section must be deposited in the general fund of the political subdivision."

Delete page 2.

Madam President: The Senate Committee on Local Government, to which was referred House Bill No. 1372, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:

Page 1, line 10, delete "The political subdivision employing a police officer who" and insert: "This subsection applies only to the nonemergency transport to a facility by the county sheriff or deputy sheriff of an individual who:

- (1) is not in lawful detention (as defined in IC 36-2-13-18);
- (2) has had an application for the individual's detention under section 1 of this chapter endorsed by a judicial officer; and
- (3) is transported more than thirty (30) miles.

The county sheriff may be reimbursed from the individual's health care coverage, including health coverage offered or administered by the state.".

Page 1, delete lines 11 through 15.
