A BILL FOR AN ACT to amend the Indiana Code concerning motor vehicles.

32	Sec. 1. The bureau shall design and issue an epilepsy foundation
33	trust license plate as a special group recognition license plate under
34	IC 9-18.5-12.
35	Sec. 2. A person that is eligible to register a vehicle under this
36	title is eligible to receive an epilepsy foundation trust license plate
37	under this chapter upon doing the following:
38	(1) Completing an application for an epilepsy foundation trust
39	license plate.
40	(2) Paying the fees under section 3 of this chapter.
41	Sec. 3. (a) The fees for an epilepsy foundation trust license plate
42	are as follows:



1	(1) An annual supplemental fee of fifteen dollars (\$15) under
2	IC 9-18.5-12-16.
3	(2) An annual fee of not more than twenty-five dollars (\$25)
4	as provided in IC 9-18.5-12-14(d)(2) or IC 9-18.5-12-15(b).
5	(b) An annual fee referred to in subsection (a)(2) must be
6	collected by the bureau and deposited in the fund established by
7	section 4 of this chapter.
8	Sec. 4. (a) The epilepsy foundation trust fund is established.
9	(b) The treasurer of state shall invest the money in the epilepsy
10	foundation trust fund not currently needed to meet the obligations
11	of the epilepsy foundation trust fund in the same manner as other
12	public trust funds are invested. Interest that accrues from these
13	investments shall be deposited in the epilepsy foundation trust
14	fund.
15	(c) The bureau shall administer the epilepsy foundation trust
16	fund. Expenses of administering the epilepsy foundation trust fund
17	shall be paid from money in the epilepsy foundation trust fund.
18	(d) On June 30 of each year, the bureau shall distribute the
19	money from the fund to the Epilepsy Foundation of Indiana.
20	(e) Money in the fund at the end of the state fiscal year does not
21	revert to the state general fund.
