DIGEST OF INTRODUCED BILL

Citations Affected: IC 8-23; IC 9-21; IC 33-37.

Synopsis: Worksite speed control pilot program. Requires the Indiana department of transportation (department) to establish the worksite speed control pilot program (pilot program) for the purpose of enforcing worksite speed limits. Requires that the department: (1) work with the state police department to administer the pilot program; and (2) enter into an agreement with the state police department to share information regarding the pilot program. Permits the department to contract with a third party vendor to assist in implementing the pilot program. Provides that an individual who is recorded by a worksite speed control system may not be assessed a civil penalty unless the violation is at least 11 miles per hour above the established worksite speed limit. Replaces the term "work zone" with "worksite" throughout the relevant statutes.

32	means a photographic device, radar device, laser device, or other
33	electrical or mechanical device or devices designed to:

35	(2) obtain a clear photograph or other recorded image of the
36	rear of the motor vehicle and the license plate affixed to the
37	motor vehicle at the time the recorded speed of the motor

40	operator" means a person described in section 13 of this chapter.

may not be used as evidence of a violation under this chapter.

2	pilot program are confidential under IC 5-14-3.
3	(d) Except as otherwise provided in this section, information
4	and photographs or recorded images collected under the pilot
5	program are not discoverable by court order as evidence in a

8	(e) Information and a photograph or recorded image collected
9	under the pilot program must be destroyed not later than two (2)

14	are the exclusive property of the state of Indiana and not the

23	civil penalty for which the photograph or recorded image was

7	vehicle that is the subject of a photograph or recorded image was

29	charged with an infraction for a violation of IC 9-21-5-11.
30	(b) The department shall assess a civil penalty against a person
31	who exceeds a worksite speed limit if the worksite speed control
32	system indicates that the operator of a motor vehicle has exceeded
33	the worksite speed limit by at least eleven (11) miles per hour.
34	(c) A person who exceeds a worksite speed limit that is detected
35	under this chapter is subject to the following civil penalties:

21	a worksite speed limit is detected and enforced through a worksite
22	speed control system under IC 8-23-32. If judgment has been
23	imposed for committing two (2) infractions under this section within
24	one (1) year, an additional penalty of the suspension of the driving
25	privileges of the person who committed the infractions may be imposed
