# ENGROSSED HOUSE BILL No. 1384

---

DIGEST OF HB 1384 (Updated March 10, 2021 4:01 pm - DI 110)

**Citations Affected:** IC 20-19; IC 20-30.

**Synopsis:** Civics education. Requires, not later than July 1, 2022, the state board of education, in coordination with the department of education, to establish standards for civics education. Establishes the: (1) Indiana civic education commission; and (2) duties of the commission. Provides that each school corporation, charter school, and state accredited nonpublic school shall require each student to successfully complete in grade 6, 7, or 8 one semester of a civics education course. Provides that the civics education standards in effect on July 2, 2022, may only be changed by the express authorization of the general assembly.

**Effective:** Upon passage; July 1, 2021.

## ENGROSSED HOUSE BILL No. 1384

A BILL FOR AN ACT to amend the Indiana Code concerning education.

*Be it enacted by the General Assembly of the State of Indiana:*

1 SECTION 1. IC 20-19-2-14.7 IS ADDED TO THE INDIANA  
2 CODE AS A **NEW** SECTION TO READ AS FOLLOWS  
3 [EFFECTIVE UPON PASSAGE]: **Sec. 14.7. (a) Not later than July**  
4 **1, 2022, the state board shall, in coordination with the department,**  
5 **establish standards for civics education.**

6 **(b) The standards established under subsection (a) and in effect**  
7 **on July 2, 2022, may only be changed by the express authorization**  
8 **of the general assembly.**

9 SECTION 2. IC 20-19-10 IS ADDED TO THE INDIANA CODE  
10 AS A **NEW** CHAPTER TO READ AS FOLLOWS [EFFECTIVE  
11 JULY 1, 2021]:

12 **Chapter 10. Indiana Civic Education Commission**

13 **Sec. 1. As used in this chapter, "commission" refers to the**  
14 **Indiana civic education commission established by section 2 of this**  
15 **chapter.**

16 **Sec. 2. The Indiana civic education commission is established.**

17 **Sec. 3. The commission consists of the following fifteen (15)**

- 4 (2) The chief justice of Indiana or the chief justice's designee.
- 5 (3) The secretary of state or the secretary of state's designee.
- 6 (4) The secretary of education or the secretary's designee.
- 7 (5) One (1) legislative member appointed by the speaker of the
- 8 **house of representatives.**
- 9 (6) One (1) legislative member appointed by the minority
- 10 **leader of the house of representatives.**
- 11 (7) One (1) legislative member appointed by the president pro
- 12 **tempore of the senate.**
- 13 (8) One (1) legislative member appointed by the minority
- 14 **leader of the senate.**
- 15 (9) The following members appointed by the governor:
- 16 (A) One (1) member representing the Indiana Bar
- 17 **Foundation.**
- 18 (B) One (1) member representing a nonprofit organization
- 19 **that has expertise working with urban youth.**
- 20 (C) One (1) member who is a superintendent of a school
- 21 **corporation.**
- 22 (D) Two (2) members who:
- 23 (i) are teachers; and
- 24 (ii) hold a teaching license in social studies, history, or
- 25 **government.**
- 26 (E) Two (2) members representing teacher preparation
- 27 **programs.**
- 28 **Sec. 4. (a) The lieutenant governor or the lieutenant governor's**
- 29 **designee shall serve as the chairperson of the commission.**
- 30 **(b) The commission shall meet at the call of the chairperson.**
- 31 **Sec. 5. (a) Eight (8) members of the commission constitute a**
- 32 **quorum.**
- 33 **(b) The affirmative vote of at least a majority of the members at**
- 34 **a meeting at which a quorum is present is necessary for the**
- 35 **commission to take official action other than to meet and take**
- 36 **testimony.**
- 37 **Sec. 6. (a) A member of the commission appointed under section**
- 38 **3(5) through 3(9) of this chapter may be removed from the**
- 39 **commission by the member's appointing authority for just cause.**
- 40 **(b) Vacancies in the appointments to the commission shall be**
- 41 **filled by the appointing authority. A member appointed under this**
- 42 **subsection serves for the remainder of the unexpired term.**



1           **Sec. 7. (a) Each member of the commission who is not a state**  
 2 **employee is entitled to the minimum salary per diem provided by**  
 3 **IC 4-10-11-2.1(b). The member is also entitled to reimbursement**  
 4 **for traveling expenses as provided under IC 4-13-1-4 and other**  
 5 **expenses actually incurred in connection with the member's duties**  
 6 **as provided in the state policies and procedures established by the**  
 7 **Indiana department of administration and approved by the budget**  
 8 **agency.**

9           **(b) Each member of the commission who is a state employee is**  
 10 **entitled to reimbursement for traveling expenses as provided under**  
 11 **IC 4-13-1-4 and other expenses actually incurred in connection**  
 12 **with the member's duties as provided in the state policies and**  
 13 **procedures established by the Indiana department of**  
 14 **administration and approved by the budget agency.**

15           **(c) Each member of the commission who is a member of the**  
 16 **general assembly is entitled to receive the same per diem, mileage,**  
 17 **and travel allowances paid to members of the general assembly**  
 18 **serving on interim study committees created by the legislative**  
 19 **council.**

20           **Sec. 8. The commission shall do the following:**

21           **(1) Discuss and review the most up to date information**  
 22 **regarding best practices, pedagogy, and policy for civics**  
 23 **education.**

24           **(2) Make recommendations and provide guidance for**  
 25 **statewide implementation of the recommendations established**  
 26 **by the 2020 Indiana civic education task force and any other**  
 27 **recommendations established by the commission.**

28           **(3) Make, as applicable, recommendations to the general**  
 29 **assembly, the state board, and the department regarding**  
 30 **civics education.**

31           **Sec. 9. The department shall staff the commission.**

32           **SECTION 3. IC 20-30-5-7.3 IS ADDED TO THE INDIANA CODE**  
 33 **AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY**  
 34 **1, 2021]: Sec. 7.3. Beginning with students entering grade 6 in the**  
 35 **2023-2024 school year, each school corporation, charter school,**  
 36 **and state accredited nonpublic school shall require each student of**  
 37 **the school corporation, charter school, or state accredited**  
 38 **nonpublic school to successfully complete in grade 6, 7, or 8 one (1)**  
 39 **semester of a civics education course.**

40           **SECTION 4. An emergency is declared for this act.**

Page 3, line 29, after "Sec. 7.3." insert "(a)".

Page 3, between lines 34 and 35, begin a new paragraph and insert:

**"(b) The standards in effect on July 1, 2023, for a civics course described in subsection (a) may only be changed by the express authorization of the general assembly."**
