DIGEST OF INTRODUCED BILL

Synopsis: Epilepsy foundation trust license plate. Establishes the epilepsy foundation trust license plate as a special group recognition license plate. Establishes the epilepsy foundation trust fund.

Effective: July 1, 2023.

HOUSE BILL No. 1387

A BILL FOR AN ACT to amend the Indiana Code concerning motor vehicles.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 9-18.5-2-1, AS AMENDED BY P.L.118-2022,
2 SECTION 7, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2023]: Sec. 1. (a) A person may apply to the bureau for a
4 personalized license plate to display on the person's vehicle.
5 (b) The following license plates may be designed as a personalized
6 license plate under this chapter:

27 SECTION 2. IC 9-18.5-36 IS ADDED TO THE INDIANA CODE
 28 AS A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE
 29 JULY 1, 2023]:

30 **Chapter 36. Epilepsy Foundation Trust License Plates**

31 **Sec. 1. The bureau shall design and issue an epilepsy foundation**
 32 **trust license plate as a special group recognition license plate under**
 33 **IC 9-18.5-12, and must include the following:**

- 34 (1) A basic design for the plate, with consecutive numbers or
 35 letters, or both, to properly identify the vehicle.
 36 (2) A background design, an emblem, or colors that designate
 37 the license plate as an epilepsy foundation trust license plate.
 38 (3) Any other information the bureau considers necessary.

39 **Sec. 2. A person that is eligible to register a vehicle under this**
 40 **title is eligible to receive an epilepsy foundation trust license plate**
 41 **under this chapter upon doing the following:**

- 42 (1) Completing an application for an epilepsy foundation trust

- 2 **(2) Paying the fees under section 3 of this chapter.**
- 3 **Sec. 3. (a) The bureau shall collect the following fees for an**
- 4 **epilepsy foundation trust license plate:**
- 5 **(1) An annual supplemental fee of fifteen dollars (\$15) under**
- 6 **IC 9-18.5-12-16.**
- 7 **(2) An annual fee of not more than twenty-five dollars (\$25)**
- 8 **under IC 9-18.5-12-14(d)(2) or IC 9-18.5-12-15(b).**
- 9 **(b) The bureau shall collect the annual fee described in**
- 10 **subsection (a)(2) and deposit the annual fee in the epilepsy**
- 11 **foundation trust fund established by section 4 of this chapter.**
- 12 **Sec. 4. (a) The epilepsy foundation trust fund is established.**
- 13 **(b) The treasurer of state shall invest the money in the epilepsy**
- 14 **foundation trust fund not currently needed to meet the obligations**
- 15 **of the epilepsy foundation trust fund in the same manner as other**
- 16 **public trust funds are invested. Interest that accrues from these**
- 17 **investments shall be deposited in the epilepsy foundation trust**
- 18 **fund.**
- 19 **(c) The bureau shall administer the epilepsy foundation trust**
- 20 **fund. Expenses of administering the epilepsy foundation trust fund**
- 21 **shall be paid from money in the epilepsy foundation trust fund.**
- 22 **(d) The bureau shall distribute at least one (1) time each month**
- 23 **the money from the epilepsy foundation trust fund to the Epilepsy**
- 24 **Foundation of Indiana.**
- 25 **(e) Money in the fund at the end of the state fiscal year does not**
- 26 **revert to the state general fund.**
