## HOUSE BILL No. 1390

A BILL FOR AN ACT to amend the Indiana Code concerning motor vehicles.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1 SECTION 1. IC 9-18.5-2-1, AS AMENDED BY P.L.256-2017,  
2 SECTION 133, IS AMENDED TO READ AS FOLLOWS  
3 [EFFECTIVE JULY 1, 2020]: Sec. 1. (a) A person may apply to the  
4 bureau for a personalized license plate to display on the person's  
5 vehicle.  
6 (b) The following license plates may be designed as a personalized  
7 license plate under this chapter:  
8 (1) IC 9-18.5-4 (prisoner of war license plates).  
9 (2) IC 9-18.5-5 (disabled Hoosier veteran license plates).  
10 (3) IC 9-18.5-6 (Purple Heart license plates).

27 SECTION 2. IC 9-18.5-35 IS ADDED TO THE INDIANA CODE  
 28 AS A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE  
 29 JULY 1, 2020]:

30 **Chapter 35. Epilepsy Foundation Trust License Plates**

31 **Sec. 1. The bureau shall design and issue an epilepsy foundation**  
 32 **trust license plate as a special group recognition license plate under**  
 33 **IC 9-18.5-12.**

34 **Sec. 2. A person that is eligible to register a vehicle under this**  
 35 **title is eligible to receive an epilepsy foundation trust license plate**  
 36 **under this chapter upon doing the following:**

37 **(1) Completing an application for an epilepsy foundation trust**  
 38 **license plate.**

39 **(2) Paying the fees under section 3 of this chapter.**

40 **Sec. 3. (a) The fees for an epilepsy foundation trust license plate**  
 41 **are as follows:**

42 **(1) An annual supplemental fee of fifteen dollars (\$15) under**

2           **(2) An annual fee of not more than twenty-five dollars (\$25)**  
3           **as provided in IC 9-18.5-12-14(d)(2) or IC 9-18.5-12-15(b).**  
4           **(b) An annual fee referred to in subsection (a)(2) must be**  
5           **collected by the bureau and deposited in the fund established by**  
6           **section 4 of this chapter.**  
7           **Sec. 4. (a) The epilepsy foundation trust fund is established.**  
8           **(b) The treasurer of state shall invest the money in the epilepsy**  
9           **foundation trust fund not currently needed to meet the obligations**  
10           **of the epilepsy foundation trust fund in the same manner as other**  
11           **public trust funds are invested. Interest that accrues from these**  
12           **investments shall be deposited in the epilepsy foundation trust**  
13           **fund.**  
14           **(c) The bureau shall administer the epilepsy foundation trust**  
15           **fund. Expenses of administering the epilepsy foundation trust fund**  
16           **shall be paid from money in the epilepsy foundation trust fund.**  
17           **(d) On June 30 of each year, the bureau shall distribute the**  
18           **money from the fund to the Epilepsy Foundation of Indiana.**  
19           **(e) Money in the fund at the end of the state fiscal year does not**  
20           **revert to the state general fund.**
