#### HOUSE BILL No. 1403

DIGEST OF HB 1403 (Updated January 22, 2020 4:54 pm - DI 129)

Citations Affected: IC 13-11; IC 13-20.

**Synopsis:** Waste tires. Adds a definition of "used tire", for purposes of the law governing solid waste management. Adds requirements for the adoption of administrative rules concerning the regulation of waste tire storage sites and waste tire processing operations.

Effective: July 1, 2020.

## HOUSE BILL No. 1403

A BILL FOR AN ACT to amend the Indiana Code concerning environmental law.

Be it enacted by the General Assembly of the State of Indiana:

| 13 | (B) allows access for emergency equipment.                         |
| 14 | (3) The tire is stored out of the weather to prevent               |
| 15 | accumulation of water or precipitation in the tires.               |
