DIGEST OF HB 1408 (Updated February 8, 2017 12:04 pm - DI 84)

Citations Affected: IC 16-18; IC 16-41.

Synopsis: Nonresidential on-site sewage system permit. Requires the state department of health to grant or deny an application for a permit to construct a nonresidential on-site sewage system within 45 days after the permit application is submitted to the state department.

Effective: July 1, 2017.

HOUSE BILL No. 1408

A BILL FOR AN ACT to amend the Indiana Code concerning health.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 16-18-2-253.2 IS ADDED TO THE INDIANA
2 CODE AS A **NEW** SECTION TO READ AS FOLLOWS
3 [EFFECTIVE JULY 1, 2017]: **Sec. 253.2. "Nonresidential on-site**
4 **sewage system", for purposes of IC 16-41-25.5, has the meaning set**
5 **forth in IC 16-41-25.5-1.**

6 SECTION 2. IC 16-41-25.5 IS ADDED TO THE INDIANA CODE
7 AS A **NEW** CHAPTER TO READ AS FOLLOWS [EFFECTIVE
8 JULY 1, 2017]:

9 **Chapter 25.5. Health, Sanitation, and Safety: Nonresidential**
10 **On-Site Sewage Systems**

11 **Sec. 1. (a) As used in this chapter, "nonresidential on-site**
12 **sewage system" means all equipment and devices necessary for**
13 **proper conduction, collection, storage, treatment, and on-site**
14 **disposal of sewage from a building other than a single family or**
15 **two-family dwelling.**

16 **(b) The term includes all building sewers, grease traps, septic**
17 **tanks, dosing tanks, absorption fields, perimeter drains, vault**

1 privies, and temporary sewage holding tanks serving one (1) of the
2 following:

- 3 (1) An apartment building.
- 4 (2) A church or other place of worship.
- 5 (3) A commercial establishment.
- 6 (4) A condominium.
- 7 (5) A medical facility.
- 8 (6) A motel.
- 9 (7) An office building.
- 10 (8) A restaurant.
- 11 (9) A school.

12 **Sec. 2. The state department shall:**

- 13 (1) issue; or
 - 14 (2) deny, in a writing transmitted to the applicant;
- 15 a permit for the construction of a nonresidential on-site sewage
16 system not more than forty-five (45) days after the submission to
17 the state department of the permit application and any other
18 materials that the rules of the state department require to be
19 submitted along with the application.
