Synopsis: Property tax sales. Provides that costs directly attributable to the sale of a property tax certificate of sale include all costs of all county offices and not only the costs of the county executive.

A BILL FOR AN ACT to amend the Indiana Code concerning local government.

Be it enacted by the General Assembly of the State of Indiana:

SECTION 1. IC 6-1.1-24-6.1, AS AMENDED BY P.L.203-2013,

2	SECTION 8, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3	JULY 1, 2014]: Sec. 6.1. (a) The county executive may do the
4	following:
5	(1) By resolution, identify properties:

13	(B) a listing of parcels on which certificates will be offered by
14	parcel number and minimum bid amount;
15	once each week for three (3) consecutive weeks, with the fina

3	(3) Sell each certificate of sale covered by the resolution for a

9	(b) Notice of the list of properties prepared under subsection (a) and

14	(2) specify that the county executive will accept bids for the

19	(A) the amount of the minimum bid under section 5 of this

24	(C) the attorney's fees and costs of giving notice under

26	(D) the costs of a title search or of examining and updating the

28	(E) all taxes and special assessments on the tract or item of

33	(F) all costs of sale, advertising costs, and other expenses of
