

HOUSE BILL No. 1424

DIGEST OF INTRODUCED BILL

Citations Affected: IC 9-18-25.

Synopsis: Special group recognition license plates. Authorizes the Independent Colleges of Indiana to act as the intermediary for the purpose of distributing special group recognition license plates (plates) to member institutions that are unable to meet the 500 plate sales requirement. Allows the bureau of motor vehicles to disclose personal information concerning plate holders to member institutions under certain circumstances, for certain purposes.

Effective: July 1, 2015.

HOUSE BILL No. 1424



A BILL FOR AN ACT to amend the Indiana Code concerning motor vehicles.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 9-18-25-15.5, AS ADDED BY P.L.107-2013,
2 SECTION 18, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2015]: Sec. 15.5. (a) ~~This section applies after January 1,~~
4 ~~2014.~~
5 (b) (a) In order to continue participation in the special group
6 recognition license plate program, a special group must:
7 (1) sell at least five hundred (500) special group recognition
8 license plates of the special group in the first two (2) years in
9 which the license plate is offered for sale; and
10 (2) maintain the sale or renewal of at least five hundred (500)
11 special group recognition license plates during each subsequent
12 year after the initial two (2) year period of sale.
13 (b) **This section applies only to the colleges and universities that**
14 **form the Independent Colleges of Indiana. Notwithstanding**
15 **subsection (a), the Independent Colleges of Indiana may act as the**



1 intermediary for the purpose of distributing special group
2 recognition license plates to member institutions that are:

3 (1) listed in IC 21-7-13-6; and

4 (2) unable to meet the five hundred (500) special group
5 recognition license plate sales requirement set forth in
6 subsection (a).

7 (c) If the special group fails to sell or renew special group
8 recognition license plates in the manner provided in subsection ~~(b)~~, (a),
9 the bureau shall place the issuance of the special group recognition
10 license plates for the special group on probation for the subsequent
11 year. If, in that subsequent year on probation, the special group fails to
12 sell or renew at least five hundred (500) special group recognition
13 license plates, the bureau shall terminate the participation of the special
14 group in the special group recognition license plate program. If the
15 special group sells or renews at least five hundred (500) special group
16 recognition license plates in the year on probation, the participation of
17 the special group in the special group recognition license plate program
18 is continued. A special group shall be afforded only one (1)
19 probationary period under this subsection.

20 (d) A special group that desires to participate in the special group
21 recognition license plate program after termination by the bureau as set
22 forth in subsection (c) must follow the procedure set forth in section 2.3
23 of this chapter.

24 SECTION 2. IC 9-18-25-19 IS ADDED TO THE INDIANA CODE
25 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
26 1, 2015]: **Sec. 19. (a) Notwithstanding section 18 of this chapter, the**
27 **bureau shall disclose personal information included on the**
28 **application form for a special group recognition license plate from**
29 **an Independent Colleges of Indiana member institution unless the**
30 **applicant makes an affirmative statement against the disclosure.**

31 (b) If the applicant does not make an affirmative statement
32 against disclosure as described in subsection (a), the bureau shall
33 disclose personal information about the applicant included on the
34 application form only to the member institution that sponsors the
35 license plate.

36 (c) If a member institution receives personal information
37 disclosed under subsection (a), the member institution may:

38 (1) contact the applicant with information about activities of
39 the member institution;

40 (2) not contact the applicant primarily for fundraising or
41 solicitation purposes; and

42 (3) not disclose the personal information of the applicant to



1 **any other person or group without the written consent of the**
2 **applicant.**
