

HOUSE BILL No. 1441

DIGEST OF INTRODUCED BILL

Citations Affected: IC 33-28-5-18.

Synopsis: Jury duty deferrals for postsecondary students. Provides that a prospective juror who is a full-time student enrolled in and attending an approved postsecondary educational institution during an academic year shall be exempted from jury service until the end of the academic year if: (1) the prospective juror requests a deferral by notifying the jury administrator that the prospective juror is a full-time student enrolled in and attending an approved postsecondary educational institution; (2) the prospective juror provides proof to the jury administrator that the jury service will likely interfere with the prospective juror's class schedule during the academic year; and (3) the court determines that the prospective juror has demonstrated that a deferral until the end of the academic year is necessary due to likely interference with the prospective juror's class schedule during the academic year.

HOUSE BILL No. 1441

A BILL FOR AN ACT to amend the Indiana Code concerning courts and court officers.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 33-28-5-18, AS AMENDED BY P.L.157-2009,
2 SECTION 1, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2015]: Sec. 18. (a) The supervising judge or the jury
4 administrator shall determine whether a prospective juror is qualified
5 to serve or, if disabled but otherwise qualified, whether the prospective
6 juror could serve with reasonable accommodation. A person who is not
7 eligible for jury service may not serve. The facts supporting juror
8 disqualification or exemption must be recorded under oath or
9 affirmation. A disqualification or exemption is not authorized unless
10 supported by the facts. The jury administrator shall make a record of all
11 disqualifications.

12 (b) A prospective juror is disqualified to serve on a jury if any of the
13 following conditions exist:

14 (1) The person is not a citizen of the United States, at least
15 eighteen (18) years of age, and a resident of the county.



- 1 (2) The person is unable to read, speak, and understand the
 2 English language with a degree of proficiency sufficient to fill out
 3 satisfactorily a juror qualification form.
- 4 (3) The person is incapable of rendering satisfactory jury service
 5 due to physical or mental disability. However, a person claiming
 6 this disqualification may be required to submit a physician's or
 7 authorized Christian Science practitioner's certificate confirming
 8 the disability, and the certifying physician or practitioner is then
 9 subject to inquiry by the court at the court's discretion.
- 10 (4) A guardian has been appointed for the person under IC 29-3
 11 because the person has a mental incapacity.
- 12 (5) The person has had the right to vote revoked by reason of a
 13 felony conviction and the right has not been restored.
- 14 (c) A person scheduled to appear for jury service has the right to
 15 defer the date of the person's initial appearance for jury service one (1)
 16 time upon a showing of hardship, extreme inconvenience, or necessity.
 17 The court shall grant a prospective juror's request for deferral if the
 18 following conditions are met:
- 19 (1) The prospective juror has not previously been granted a
 20 deferral.
- 21 (2) The prospective juror requests a deferral by contacting the
 22 jury administrator:
- 23 (A) by telephone;
 24 (B) by electronic mail;
 25 (C) in writing; or
 26 (D) in person.
- 27 (3) The prospective juror selects another date on which the
 28 prospective juror will appear for jury service that is:
- 29 (A) not more than one (1) year after the date upon which the
 30 prospective juror was originally scheduled to appear; and
 31 (B) a date when the court will be in session.
- 32 (4) The court determines that the prospective juror has
 33 demonstrated that a deferral is necessary due to:
- 34 (A) hardship;
 35 (B) extreme inconvenience; or
 36 (C) necessity.
- 37 **(d) Notwithstanding subsection (c), a prospective juror who is**
 38 **a full-time student enrolled in and attending an approved**
 39 **postsecondary educational institution (as defined in IC 21-7-13-6)**
 40 **during an academic year shall be exempted from jury service until**
 41 **the end of the academic year if:**
- 42 **(1) the prospective juror requests a deferral by notifying the**



- 1 **jury administrator that the prospective juror is a full-time**
 2 **student enrolled in and attending an approved postsecondary**
 3 **educational institution;**
 4 **(2) the prospective juror provides proof to the jury**
 5 **administrator that the jury service will likely interfere with**
 6 **the prospective juror's class schedule during the academic**
 7 **year; and**
 8 **(3) the court determines that the prospective juror has**
 9 **demonstrated that a deferral until the end of the academic**
 10 **year is necessary due to likely interference with the**
 11 **prospective juror's class schedule during the academic year.**
- 12 ~~(d)~~ **(e)** A prospective juror who is at least seventy-five (75) years of
 13 age may be exempted from jury service if the prospective juror notifies
 14 the jury administrator that the prospective juror is at least seventy-five
 15 (75) years of age and wishes to be exempted from jury service.
- 16 ~~(e)~~ **(f)** A person may not serve as a petit juror in any county if the
 17 person served as a petit juror in the same county within the previous
 18 three hundred sixty-five (365) days in a case that resulted in a verdict.
 19 The fact that a person's selection as a juror would violate this
 20 subsection is sufficient cause for challenge.
- 21 ~~(f)~~ **(g)** A grand jury, a petit jury, or an individual juror drawn for
 22 service in one (1) court may serve in another court of the county, in
 23 accordance with orders entered on the record in each of the courts.
- 24 ~~(g)~~ **(h)** The same petit jurors may be used in civil cases and in
 25 criminal cases.
- 26 ~~(h)~~ **(i)** A person may not be excluded from jury service on account
 27 of race, color, religion, sex, national origin, or economic status.
