DIGEST OF INTRODUCED BILL

Citations Affected: IC 16-21-2-18.

Synopsis: Emergency department substance use plans. Requires an emergency department to: (1) annually submit to the Indiana department of health (department) a plan to initiate interventions with patients who have a substance use related emergency department visit; and (2) implement a continuing education and training program to emergency department personnel on substance use disorder and best practices for emergency medical care delivery for patients who are most at risk of dying after emergency room discharge. Provides that the services provided to a patient under a substance use disorder treatment plan provided to the department are considered to be medically necessary. Provides that the office of the secretary of family and social services shall require managed care organizations to consider services provided to an individual under a substance use disorder treatment plan as medically necessary.

Effective: July 1, 2023.

HOUSE BILL No. 1462

A BILL FOR AN ACT to amend the Indiana Code concerning health.

Be it enacted by the General Assembly of the State of Indiana:

1	SECTION 1. IC 16-21-2-18 IS ADDED TO THE INDIANA CODE
2	AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
3	1, 2023]: Sec. 18. (a) This section applies to an emergency
4	department that is owned or operated by hospital licensed under
5	IC 16-21.
6	(b) As used in this section, "substance use disorder" includes:
7	(1) opioid use disorder;
8	(2) alcohol use disorder; and
9	(3) any other substance use disorder determined by the state
0	department.
1	(c) Before December 31 of each year, an emergency department
2	must submit a substance use disorder treatment plan with the state
3	department for the subsequent year to initiate interventions with
4	patients who have a substance use related emergency department
5	visit. The plan must include the following:
6	(1) A detailed protocol to connect patients with substance use
7	disorders to treatment, prevention, recovery, peer support



1	services, and harm reduction services upon discharge from
2	the emergency department.
3	(2) An incorporation of the screening, brief intervention, and
4	referral to treatment screening tool.
5	(3) A procedure to initiate or connect substance use patients
6	to medication assisted treatment for addiction disorders,
7	including:
8	(A) treatment for opioid use disorder and alcohol use
9	disorder; and
10	(B) providing immediate access to:
11	(i) naloxone;
12	(ii) an opioid antagonist that can reverse opioid
13	overdoses; and
14	(iii) all federal Food and Drug Administration approved
15	medications for the treatment of opioid use disorder and
16	alcohol use disorder.
17	(4) An analysis of the emergency department's ability to and
18	a plan to:
19	(A) begin initiation of medication before discharge; and
20	(B) coordinate outpatient medication referrals upon
21	discharge.
22	(d) The services provided to a patient under a substance use
23	disorder treatment plan provided to the state department under
24	this section are considered to be medically necessary.
25	(e) The office of the secretary of family and social services shall
26	require managed care organizations to consider services provided
27	to an individual under a substance use disorder treatment plan that
28	is provided to the state department as medically necessary.
29	(f) After December 31, 2023, an emergency department must
30	implement a continuing education and training program to
31	emergency department personnel on:
32	(1) substance use disorder; and
33	(2) best practices for emergency medical care delivery for
34	patients who are most at risk of dying after emergency room
35	discharge.
36	(g) The state department may adopt rules under IC 4-22-2 to
37	implement this chapter.
