## DIGEST OF INTRODUCED BILL

**Citations Affected:** IC 20-43-10-4.

**Synopsis:** Small school grant. Provides a small school grant in state fiscal years 2015-2016 and 2016-2017 to school corporations, other than charter schools, that have a current average daily membership (ADM) that is greater than 450 and less than 1,100. Appropriates the amount necessary to fund the grants from the state general fund.

**Effective:** July 1, 2015.

## HOUSE BILL No. 1480

---

A BILL FOR AN ACT to amend the Indiana Code concerning education and to make an appropriation.

*Be it enacted by the General Assembly of the State of Indiana:*

1       SECTION 1. IC 20-43-10-4 IS ADDED TO THE INDIANA CODE  
2       AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY  
3       1, 2015]: **Sec. 4. (a) This section applies for a state fiscal year only**  
4       **to a school corporation that has a current ADM that is:**

- 5               **(1) greater than four hundred fifty (450); and**  
6               **(2) less than one thousand one hundred (1,100).**

7       **This section does not apply to a charter school.**

8       **(b) The grant amount determined for a school corporation**  
9       **under this section for each state fiscal year constitutes a small**  
10       **school grant that is in addition to state tuition support for that**  
11       **state fiscal year. The small school grant for a state fiscal year shall**  
12       **be distributed to the school corporation before December 5 of that**  
13       **state fiscal year. The amount needed to make the distributions**  
14       **under this section is appropriated from the state general fund.**

15       **(c) If the school corporation's current ADM is at least five**



1 hundred (500) and less than one thousand one (1,001), the grant  
2 amount for the state fiscal year is three hundred thousand dollars  
3 (\$300,000).

4 (d) If the school corporation's current ADM is greater than four  
5 hundred fifty (450) and less than five hundred (500), the grant  
6 amount for the state fiscal year is:

7 (1) the school corporation's current ADM minus four hundred  
8 fifty (450); multiplied by

9 (2) six thousand dollars (\$6,000).

10 (e) If the school corporation's current ADM is greater than one  
11 thousand (1,000) and less than one thousand one hundred (1,100),  
12 the grant amount for the state fiscal year is three hundred  
13 thousand dollars (\$300,000) minus:

14 (1) the school corporation's current ADM minus one thousand  
15 (1,000); multiplied by

16 (2) three thousand dollars (\$3,000).

17 (f) This section expires June 30, 2017.
