DIGEST OF HB 1501 (Updated March 9, 2015 11:05 am - DI 92)

Citations Affected: IC 15-16.

**Synopsis:** Invasive species council. Extends the expiration date of the invasive species council from July 1, 2015, to July 1, 2023. Makes technical changes.

**Effective:** June 30, 2015; July 1, 2015.

A BILL FOR AN ACT to amend the Indiana Code concerning agriculture and animals.

Be it enacted by the General Assembly of the State of Indiana:

7	JULY 1, 2015]: Sec. 11. The Purdue University School College of
8	Agriculture shall provide administrative assistance to the council.
9	SECTION 3. IC 15-16-10-13, AS ADDED BY P.L.23-2009,
10	SECTION 1, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
11	JUNE 30, 2015]: Sec. 13. This chapter expires July 1, 2015. 2023.
