DIGEST OF INTRODUCED BILL

Citations Affected: IC 34-13-9-0.7; IC 34-13-9-7.5.

Synopsis: Religious freedom restoration. Repeals the following provisions of the Indiana religious freedom restoration act: (1) An application provision stating certain limitations on the statute. (2) The definition of "provider".

Effective: Upon passage.

HOUSE BILL No. 1503

A BILL FOR AN ACT to repeal certain provisions of the Indiana Code concerning civil procedure.

Be it enacted by the General Assembly of the State of Indiana:

I	SECTION 1. IC 34-13-9-0.7 IS REPEALED [EFFECTIVE UPON
2	PASSAGE]. Sec. 0.7. This chapter does not:
3	(1) authorize a provider to refuse to offer or provide services,
4	facilities, use of public accommodations, goods, employment, or
5	housing to any member or members of the general public on the
6	basis of race, color, religion, ancestry, age, national origin,
7	disability, sex, sexual orientation, gender identity, or United
8	States military service;
9	(2) establish a defense to a civil action or criminal prosecution for
10	refusal by a provider to offer or provide services, facilities, use of
11	public accommodations, goods, employment, or housing to any
12	member or members of the general public on the basis of race,
13	color, religion, ancestry, age, national origin, disability, sex,
14	sexual orientation, gender identity, or United States military
15	service; or
16	(3) negate any rights available under the Constitution of the State
17	of Indiana.

5	persons. The term does not include:
6	(1) A church or other nonprofit religious organization or society,
7	including an affiliated school, that is exempt from federal income
