Synopsis: Proof of vehicle registration. Removes the requirement that a decal or sticker issued by the bureau of motor vehicles must be displayed on a vehicle as proof of registration of the vehicle.

A BILL FOR AN ACT to amend the Indiana Code concerning motor vehicles.

4	(1) securely fastened, in a horizontal and upright position that

6	to the vehicle for which the plate is issued:

23	A plate displayed under subdivision (2) must be affixed to the window

25	(d) A temporary license plate issued by the bureau must be
26	displayed in the same manner as an interim license plate under
27	subsection (c).
28	(e) Upon the renewal of a registration under this article, a license
29	plate other than a temporary license plate must display a renewal
30	sticker:
31	(1) that is securely affixed in the upper right corner of the license
32	plate; and
33	(2) that covers the previous registration expiration year.
34	(f) (e) A person that violates this section commits a Class C
35	infraction.
