DIGEST OF INTRODUCED BILL

Citations Affected: IC 20-19-3-11.1.

Synopsis: Child abuse hotline information. Requires each school corporation and charter school to place a poster listing the Indiana child abuse and neglect hotline's telephone number in each school library and classroom within the school corporation or charter school. Describes required dimensions for the poster listing the Indiana child abuse and neglect hotline's telephone number.

Effective: July 1, 2021.

The dimensions of the child abuse hotline telephone number described in subsection (a) must be at least four (4) inches in height by fifteen (15) inches in width and include print large enough to fill the dimensions established by this subsection.
