HOUSE BILL No. 1613

DIGEST OF HB 1613 (Updated February 18, 2015 6:44 pm - DI 77)

Citations Affected: IC 12-8; IC 12-9; IC 12-13; IC 12-21; IC 12-23.

Synopsis: Family and social services administration. Specifies that the secretary of family and social services, rather than certain division directors, is: (1) the appointing authority for divisions within the office of the secretary of family and social services (office of the secretary); (2) authorized to advise the governor concerning adopted rules; (3) authorized to adopt administrative rules; (4) authorized to enter into contracts for the office of the secretary; and (5) the authority for administering specified programs and grants.

Effective: July 1, 2015.

HOUSE BILL No. 1613

A BILL FOR AN ACT to amend the Indiana Code concerning human services.

Be it enacted by the General Assembly of the State of Indiana:

1	SECTION 1. IC 12-8-1.5-7, AS ADDED BY P.L.160-2012,

IC 12-8-8.5-5, AS ADDED BY P.L.160-2012, 24 SECTION 19, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE 25 JULY 1, 2015]: Sec. 5. (a) A director The secretary is the ultimate 26 authority under IC 4-21.5 for purposes of the operation of the director's 27 division and the programs of the director's division. 28 (b) The director shall consult with the secretary on issues of family, 29 social services, or health policy arising in a proceeding under 30 IC 4-21.5. 31 SECTION 5. IC 12-8-12-2, AS AMENDED BY P.L.161-2007, 32 SECTION 8, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE 33 JULY 1, 2015]: Sec. 2. This chapter applies to all TANF recipients and 34 applicants, except recipients and applicants exempted under rules 35 adopted by the director secretary under IC 4-22-2. 36 SECTION 6. IC 12-8-12-7 IS AMENDED TO READ AS 37 FOLLOWS [EFFECTIVE JULY 1, 2015]: Sec. 7. The director 38 secretary may adopt rules under IC 4-22-2 necessary to implement this 39 chapter. 40 SECTION 7. 1 division in entering into contracts for the disbursal of money and the 2 providing of service for approved community mental retardation and 3 other developmental disability centers where constructed and operated 4 or maintained by private nonprofit organizations, a local public agency, 5 or any other state agency that the director secretary determines to be 6 best suited to advance programs for individuals with developmental 7 disabilities. 8 (b) Before entering into a contract under this section, the director 9 secretary shall submit the contract to the attorney general for approval 10 as to form and legality. (c) A contract under this section must do the following: 11 12 (1) Specify the services to be provided and the client populations 13 to whom services must be provided. 14 (2) Specify that the definition of developmental disability set forth in IC 12-7-2-61 must be used to determine the eligibility of an 15 16 individual for reimbursement of the center by the division for the center's services for individuals with a developmental disability. 17 18 The division shall reimburse the centers at rates established by 19 rule. 20 (3) Provide for a reduction in funding for failure to comply with 21 terms of the contract. 22 SECTION 8. IC 12-13-2-3 IS AMENDED TO READ AS 23 FOLLOWS [EFFECTIVE JULY 1, 2015]: Sec. 3. The director is 24 responsible for the following: 25 (1) The appointment of state investigators or boards of review provided by law that are necessary to ensure a fair hearing to an 26 27 applicant or a recipient. A fair hearing shall be granted at the 28 request of an aggrieved person who desires a hearing. The 29 division shall review cases upon the request of an applicant, a 30 recipient, or an aggrieved person. 31 (2) The adoption of all policies and rules for the division. 32 (3) The administrative and executive duties and responsibilities 33 of the division. 34 (4) The establishment of salaries for the officers and employees 35 of the division within the salary ranges of the pay plan adopted by 36 the Indiana personnel advisory board and approved by the budget 37 committee. 38 (5) The establishment of minimum standards of assistance for old 39 age and dependent children recipients. for alcoholism, compulsive gambling, or drug abuse prevention or for
 treatment in the field of addictions.

3 (b) Subsection (a) does not apply if the federal law regulating a
4 grant, loan, or gift does not allow exclusive power and control over the
5 disbursement of the grant, loan, or gift to be vested in a single state

6 authority.
