ENGROSSED HOUSE BILL No. 1613

DIGEST OF HB 1613 (Updated March 23, 2015 11:38 am - DI 104)

Citations Affected: IC 12-8; IC 12-9; IC 12-13; IC 12-21; IC 12-23.

Synopsis: Family and social services administration. Specifies that the secretary of family and social services, rather than certain division directors, is: (1) the appointing authority for divisions within the office of the secretary of family and social services (office of the secretary); (2) authorized to advise the governor concerning adopted rules; (3) authorized to adopt administrative rules; (4) authorized to enter into contracts for the office of the secretary; and (5) the authority for administering specified programs and grants.

Effective: July 1, 2015.

ENGROSSED HOUSE BILL No. 1613

A BILL FOR AN ACT to amend the Indiana Code concerning human services.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 12-8-1.5-7, AS ADDED BY P.L.160-2012,
2 SECTION 16, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2015]: Sec. 7. The secretary, through the offices, may do the
4 following:
5 (1) Employ experts and consultants to carry out the duties of the
6 secretary and the offices.
7 (2) Utilize, with the consent of the other state agencies, the
8 services and facilities of other state agencies without
9 reimbursement.
10 (3) Accept in the name of the state, for use in carrying out the
11 purposes of this article, any money or other property received as
12 a gift, by bequest, or otherwise.
13 (4) Accept voluntary and uncompensated services.
14 (5) Expend money made available according to policies enforced
15 by the budget agency.

1 (6) Establish and implement the policies and procedures

3 (7) Advise the governor concerning rules adopted by a division
4 **before July 1, 2015, or the secretary after June 30, 2015.**

7 (9) Perform other acts necessary to implement this article.

8 **(10) Perform other functions permissible under this title.**

9 SECTION 2. IC 12-8-8.5-3, AS ADDED BY P.L.160-2012,
10 SECTION 19, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
11 JULY 1, 2015]: Sec. 3. ~~A director~~ **The secretary** is the appointing
12 authority for the ~~director's~~ division.

13 SECTION 3. IC 12-8-8.5-4, AS ADDED BY P.L.160-2012,
14 SECTION 19, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
15 JULY 1, 2015]: Sec. 4. (a) ~~A director~~ **The secretary** may adopt rules
16 under IC 4-22-2 relating to the operation of the ~~director's~~ division and
17 to implement the programs of the ~~director's~~ division.

18 (b) Whenever a division is required to adopt rules under IC 4-22-2,
19 the ~~director of the division~~ **secretary** is the statutory authority that
20 adopts the rules.

21 **(c) Rules adopted by a division before July 1, 2015, are**
22 **considered, after June 30, 2015, rules of the secretary.**

23 SECTION 4. IC 12-8-8.5-5, AS ADDED BY P.L.160-2012,
24 SECTION 19, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
25 JULY 1, 2015]: Sec. 5. (a) ~~A director~~ **The secretary** is the ultimate
26 authority under IC 4-21.5 for purposes of the operation of the ~~director's~~
27 division and the programs of the ~~director's~~ division.

28 (b) ~~The director shall consult with the secretary on issues of family;~~
29 ~~social services; or health policy arising in a proceeding under~~
30 ~~IC 4-21.5.~~

31 SECTION 5. IC 12-8-12-2, AS AMENDED BY P.L.161-2007,
32 SECTION 8, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
33 JULY 1, 2015]: Sec. 2. This chapter applies to all TANF recipients and
34 applicants, except recipients and applicants exempted under rules

 2 providing of service for approved community mental retardation and
 3 other developmental disability centers where constructed and operated
 4 or maintained by private nonprofit organizations, a local public agency,
 5 or any other state agency that the ~~director~~ **secretary** determines to be
 6 best suited to advance programs for individuals with developmental
 7 disabilities.

8 (b) Before entering into a contract under this section, the ~~director~~
 9 **secretary** shall submit the contract to the attorney general for approval
 10 as to form and legality.

11 (c) A contract under this section must do the following:

12 (1) Specify the services to be provided and the client populations
 13 to whom services must be provided.

14 (2) Specify that the definition of developmental disability set forth
 15 in IC 12-7-2-61 must be used to determine the eligibility of an
 16 individual for reimbursement of the center by the division for the
 17 center's services for individuals with a developmental disability.
 18 The division shall reimburse the centers at rates established by
 19 rule.

20 (3) Provide for a reduction in funding for failure to comply with
 21 terms of the contract.

22 SECTION 8. IC 12-13-2-3 IS AMENDED TO READ AS
 23 FOLLOWS [EFFECTIVE JULY 1, 2015]: Sec. 3. The director is
 24 responsible for the following:

25 (1) The appointment of state investigators or boards of review
 26 provided by law that are necessary to ensure a fair hearing to an
 27 applicant or a recipient. A fair hearing shall be granted at the
 28 request of an aggrieved person who desires a hearing. The
 29 division shall review cases upon the request of an applicant, a
 30 recipient, or an aggrieved person.

31 (2) The adoption of all policies ~~and rules~~ for the division.

32 (3) The administrative and executive duties and responsibilities
 33 of the division.

34 (4) The establishment of salaries for the officers and employees
 35 of the division within the salary ranges of the pay plan adopted by
 36 the Indiana personnel advisory board and approved by the budget
 37 committee.

38 (5) The establishment of minimum standards of assistance for old
 39 age and dependent children recipients. A standard established
 40 under this subdivision must apply to all individuals in Indiana.

16 U.S.C. 9858 et seq. The ~~division~~ **office of the secretary** shall
17 apply to the United States Department of Health and Human
18 Services for a grant under the Child Care Development Block
19 Grant.

20 (2) The federal Food Stamp Program under 7 U.S.C. 2011 et seq.

21 SECTION 11. IC 12-21-2-7 IS AMENDED TO READ AS
22 FOLLOWS [EFFECTIVE JULY 1, 2015]: Sec. 7. (a) The ~~director~~
23 **secretary** may act for the division in entering into contracts for the
24 disbursal of money and the providing of service.

25 (b) Before entering into a contract under this section, the ~~director~~
26 **secretary** shall submit the contract to the attorney general for approval
27 as to form and legality.

28 (c) A contract under this section must do the following:

29 (1) Specify the services to be provided and the client populations
30 to whom services must be provided.

31 (2) Provide for a reduction in funding for the failure to comply
32 with terms of the contract.

33 SECTION 12. IC 12-23-1-7 IS AMENDED TO READ AS
34 FOLLOWS [EFFECTIVE JULY 1, 2015]: Sec. 7. (a) Except as
35 provided in subsection (b) and notwithstanding any other law, the
36 ~~division~~ **office of the secretary** is the sole state authority authorized to:

37 (1) disburse grants, loans, or gifts made by the federal government
38 or any other source to the state, state agencies, and subdivisions
39 of the state; and

40 (2) review and approve grants or contracts made by the federal
41 government to or with a local governmental unit or other public
42 or private agency;



1 for alcoholism, compulsive gambling, or drug abuse prevention or for

3 (b) Subsection (a) does not apply if the federal law regulating a
4 grant, loan, or gift does not allow exclusive power and control over the
5 disbursement of the grant, loan, or gift to be vested in a single state
6 authority.
