

HOUSE BILL No. 1674

DIGEST OF INTRODUCED BILL

Citations Affected: Noncode.

Synopsis: Study of school regulations. Urges the legislative council to assign to the education study committee the issue of eliminating, reducing, or streamlining education mandates placed on public schools, including charter schools.

Effective: July 1, 2019.

HOUSE BILL No. 1674

A BILL FOR AN ACT concerning education.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. [EFFECTIVE JULY 1, 2019] (a) **The definitions in**
2 **IC 20 apply throughout this SECTION.**
3 (b) **As used in this SECTION, "education mandate" means a**
4 **requirement for a public school, including a charter school,**
5 **included in the Indiana Code or an administrative rule. The term**
6 **includes all:**
7 **(1) training requirements;**
8 **(2) professional development requirements;**
9 **(3) state board or department:**
10 **(A) policies;**
11 **(B) procedures;**
12 **(C) data reporting requirements; and**
13 **(D) survey requirements; and**
14 **(4) administrative or other requirements placed on classroom**
15 **teachers that reduce the amount of time the classroom teacher**
16 **can prepare for or conduct classroom instruction.**
17 (c) **As used in this SECTION, "study committee" refers to the**
18 **interim study committee on education established by IC 2-5-1.3-4.**



- 1 **(d) The legislative council is urged to assign to the study**
- 2 **committee during the 2019 interim the study of how to eliminate,**
- 3 **reduce, or streamline the education mandates placed on public**
- 4 **schools, including charter schools.**
- 5 **(e) The study committee must include its recommendations in**
- 6 **the study committee's final report.**
- 7 **(f) This SECTION expires January 1, 2021.**
