1 A CONCURRENT RESOLUTION to allow the House of
2 Representatives and the Senate of the 122nd General Assembly
3 to adjourn and recess separately throughout the Second Regular
4 Session for periods in excess of three (3) consecutive days as
5 the need, in the judgment of the Speaker of the House of
6 Representatives and the President Pro Tempore of the Senate,
7 respectively, may arise.

8 *Whereas, The Indiana House of Representatives and the*
9 *Senate met for the purpose of organization of each House to*
10 *conduct the public business of the people of the State of*
11 *Indiana;*

12 *Whereas, During the consideration of legislative business,*
13 *each House may, in the respective judgment of the Speaker of*
14 *the House of Representatives and the President Pro Tempore of*
15 *the Senate, deem it necessary to adjourn and recess for periods*
16 *in excess of three (3) consecutive days and to operate on a*
17 *schedule different from the other House;*

18 *Whereas, Article 4, Section 10 of the Constitution of the State*
19 *of Indiana states that neither House shall, without the consent*
20 *of the other, adjourn for more than three (3) consecutive days;*

21 *Whereas, Each House desires to consent to any adjournment*
22 *or recess by the other House that might last more than three (3)*
23 *days during the Second Regular Session of the 122nd General*
24 *Assembly; and*

25 *Whereas, The House of Representatives and the Senate intend*
26 *to recess after November 16, 2021, and meet again at the fall*



1 *of the gavel to conduct legislative business: Therefore,*

2 *Be it resolved by the House of Representatives*
3 *of the General Assembly of the State of Indiana,*
4 *the Senate concurring:*

5 SECTION 1. That each House of the 122nd Indiana General
6 Assembly hereby consents to any adjournment or recess of the
7 other House during the Second Regular Session of the 122nd
8 General Assembly for a period in excess of three (3) days,
9 where such recess or adjournment is approved, in the case of
10 the Senate, by the President Pro Tempore of the Senate, or, in
11 the case of the House of Representatives, by the Speaker of the
12 House of Representatives.

13 SECTION 2. That the Principal Clerk of the House of
14 Representatives is directed to inform the Senate of the passage
15 of the Resolution.
