4 *Incorporated in January 2011 to help young ladies, and their*
5 *families, during a cherished high school tradition;*

6 *Whereas, Prom Genie, Inc. specializes in events such as their*
7 *Annual Prom Dress Give-A-Way that offers young ladies a wide*
8 *selection of dresses, shoes, jewelry, and accessories;*

9 *Whereas, The Prom Dress Give-A-Way, also known as*
10 *Boutique Day, provides a mentored experience through which*
11 *volunteers work with attendees to create a perfect ensemble,*
12 *including hair and makeup, for free;*

13 *Whereas, Prom Genie, Inc. helps young ladies fulfill their*
14 *prom dreams and higher education goals every year by*
15 *awarding a \$2,000 scholarship to two high school girls;*
