HOUSE CONCURRENT RESOLUTION No. 4

1 A CONCURRENT RESOLUTION urging the Indiana
2 Department of Transportation to rename that portion of U.S.
3 Highway 52 between Davis Road and German Church Road the
4 "Officer Breann Leath Memorial Mile".

5 *Whereas, Officer Breann Leath was a 24 year old officer with*
6 *the Indianapolis Metropolitan Police Department (IMPD),*
7 *where she served for three years;*

8 *Whereas, Prior to serving with IMPD, she was a veteran of*
9 *the Indiana National Guard and worked with the Indiana*
10 *Department of Correction;*

11 *Whereas, Officer Leath was shot and killed in the line of duty*
12 *on Thursday, April 9th, 2020, while responding to a domestic*
13 *disturbance call;*

14 *Whereas, She is survived by her young son, her parents, who*
15 *have both served with the Marion County Sheriff's Office, and*
16 *her two sisters, who have also served the public;*

17 *Whereas, Officer Leath was described by her fellow officers*
18 *as being a dedicated and compassionate public servant and an*
19 *example for all officers to follow; and*

20 *Whereas, By honoring Officer Leath, we acknowledge her and*
21 *her family's sacrifice and hold her contributions to the*
22 *community in high esteem: Therefore,*



1 *Be it resolved by the House of Representatives*
2 *of the General Assembly of the State of Indiana,*
3 *the Senate concurring:*

4 SECTION 1. That the Indiana General Assembly urges the
5 Indiana Department of Transportation to rename that portion of
6 U.S. Highway 52 between Davis Road and German Church
7 Road the "Officer Breann Leath Memorial Mile".

8 SECTION 2. That the Principal Clerk of the House of
9 Representatives shall transmit copies of this resolution to the
10 Commissioner of the Indiana Department of Transportation.
