1           A CONCURRENT RESOLUTION honoring Allan Gilbert  
2           Whitlow.

3           *Whereas, Allan Gilbert Whitlow was born on January 4,*  
4           *1939, in Michigan City and died on November 19, 2017, at his*  
5           *home in Michigan City;*

6           *Whereas, At the time of his death, Allan Whitlow was 78 years*  
7           *old;*

8           *Whereas, Allan Whitlow and Patricia married on August 26,*  
9           *1961, in Michigan City;*

10          *Whereas, Allan Whitlow graduated from Saint Joseph's*  
11          *College in 1961 and received a master's degree in arts from*  
12          *Michigan State in 1971;*

13          *Whereas, Allan Whitlow served his state and his community*  
14          *as a city councilman and as a teacher, assistant principal,*  
15          *principal, assistant superintendent, superintendent, insurance*  
16          *agent, and a former director of the Michigan City Boys and*  
17          *Girls Club chapter;*

18          *Whereas, Allan Whitlow was also an assistant coach of the*  
19          *Michigan City Elston High School boys basketball team that*  
20          *won the 1966 Indiana state championship;*

21          *Whereas, In 2006, Allan Whitlow was given the humanitarian*  
22          *of the year award for his "generous contributions, commitment*  
23          *of time, support, and inspirations to the city of Michigan City*  
24          *and its citizens";*



1       *Whereas, Allan Whitlow was a tremendous asset to Michigan*  
2       *City, and his dedication, perseverance, passion, kindness, and*  
3       *unpretentious attitude helped to improve the lives of everyone*  
4       *he touched; and*

5       *Whereas, The death of Allan Gilbert Whitlow left a void in his*  
6       *community and his state that will never be filled: Therefore,*

7               *Be it resolved by the House of Representatives*  
8               *of the General Assembly of the State of Indiana,*  
9               *the Senate concurring:*

10       SECTION 1. That the members of the Indiana General  
11       Assembly express their sincere condolences and appreciation to  
12       the family of Allan Gilbert Whitlow for his many contributions  
13       and dedicated service to the citizens of Michigan City and the  
14       state of Indiana.
