3 *Whereas, Marlee Hobbs, Mackenzie Riddle, and Morgan*
4 *Riddle are juniors at Daleville High School and have been*
5 *singing together since they were in the second grade;*

6 *Whereas, As sixth graders, the girls arranged their own*
7 *version of the national anthem and began performing it*
8 *publicly at a Daleville High School basketball game;*

9 *Whereas, Marlee Hobbs, Mackenzie Riddle, and Morgan*
10 *Riddle have continued to perform their version at community*
11 *and school functions including veterans' programs, fairs,*
12 *fundraisers, and a multitude of sporting events;*

13 *Whereas, In 2016 Marlee Hobbs, Mackenzie Riddle, and*
14 *Morgan Riddle represented their school and their community*
15 *at the state level when they sang at the Indiana High School*
16 *Athletic Association's state championship finals for*
17 *wrestling, boys' track and field, baseball, and football;*

18 *Whereas, The girls have displayed their talents at some of*
19 *Indiana's most notable venues, including Bankers Life*
20 *Fieldhouse, Indiana University's Haugh Track and Field*
21 *Complex, Victory Field, and Lucas Oil Stadium;*

22 *Whereas, In addition to performing the national anthem,*
23 *Marlee Hobbs, Mackenzie Riddle, and Morgan Riddle*
24 *participate in a variety of other school and community*

2 *Whereas, The girls are multisport athletes, members of the*
3 *National Honor Society, serve on Student Council, are*
4 *involved in their churches, and represent Daleville High*
5 *School on the county's youth drug awareness group, the*
6 *Delaware County PRIDE Team; and*

7 *Whereas, Outstanding accomplishments such as these*
8 *deserve special recognition: Therefore,*

9 *Be it resolved by the House of Representatives*
10 *of the General Assembly of the State of Indiana,*
11 *the Senate concurring:*
