8 *Whereas, On March 24, 1993, two North Vernon police*
9 *officers were killed when their cruiser was rammed by a man*
10 *who was free on bond following an earlier standoff with police;*

11 *Whereas, The officers were Officer Anthony Burton and*
12 *Reserve Officer Lonnie Howard;*

13 *Whereas, The officers' car was pushed nearly 100 feet*
14 *through a ditch, coming to rest at the current site of the State*
15 *Road 750 bypass that is to be renamed U.S. Highway 50;*

16 *Whereas, It is fitting that the people of Indiana honor the*
17 *memory of Officer Anthony Burton and Reserve Officer Lonnie*
18 *Howard; and*

19 *Whereas, The sacrifice made by Officer Burton and Reserve*
20 *Officer Howard shall never be forgotten: Therefore,*

21 *Be it resolved by the House of Representatives*
22 *of the General Assembly of the State of Indiana,*
23 *the Senate concurring:*

24 SECTION 1. That the Indiana General Assembly



1 acknowledges the great sacrifice made by Officer Anthony
2 Burton and Reserve Officer Lonnie Howard.

3 SECTION 2. That the Principal Clerk of the House of
4 Representatives transmit a copy of this resolution to the
5 families of Officer Anthony Burton and Reserve Officer Lonnie
6 Howard and the commissioner of the Indiana Department of
7 Transportation.
