6 *veterans, roughly eight percent of the state's population, who*
7 *have courageously put themselves in harm's way;*

8 *Whereas, Greenville, Indiana, is home to 448 veterans who*
9 *have served their country in the Vietnam War, the First Gulf*
10 *War, and the Second Gulf War;*

11 *Whereas, Indiana is honored to be the home of so many men*
12 *and women who have answered the call to serve their country*
13 *against all enemies and to protect the principles of life, liberty,*
14 *and the pursuit of happiness for all its citizens;*

15 *Whereas, It is our duty as regular citizens to support and pay*
16 *tribute to those who have sacrificed so much to serve their*
17 *great nation; and*

18 *Whereas, The community of Greenville, Indiana, would like*
19 *to honor their veteran neighbors by naming a bridge to*
20 *commemorate all who served the entire country: Therefore,*

21 *Be it resolved by the House of Representatives*
22 *of the General Assembly of the State of Indiana,*
23 *the Senate concurring:*

24 SECTION 1. That the Indiana General Assembly urges the
