1           A CONCURRENT RESOLUTION congratulating the Indiana  
2 Catholic Conference on the 50th anniversary of its founding.

3           *Whereas, Since 1967, The Indiana Catholic Conference*  
4 *has served the people of Indiana and the Roman Catholic*  
5 *Church;*

6           *Whereas, The Indiana Catholic Conference's purpose is to*  
7 *serve the spiritual, moral, and material well-being of the*  
8 *people of the state;*

9           *Whereas, The Indiana Catholic Conference is the statewide*  
10 *coordinating body for the five Roman Catholic dioceses in*  
11 *Indiana;*

12           *Whereas, The Indiana Catholic Conference is the official*  
13 *public policy voice of the Catholic Church in Indiana*  
14 *regarding state and national matters;*

15           *Whereas, The Indiana Catholic Conference develops*  
16 *cooperative relationships with religious and civic, social,*  
17 *and governmental units where common public policy*  
18 *interests exist;*

19           *Whereas, The Catholic Conference is a liaison between the*  
20 *Catholic Church in Indiana and national Catholic groups in*  
21 *areas of common public policy interests;*

22           *Whereas, The Indiana Catholic Conference provides a*  
23 *readily accessible source to which public inquiry can be*



1 *made about the position of the Church on matters affecting*  
2 *the common good; and*

3 *Whereas, The Indiana Catholic Conference provides*  
4 *communication and understanding among Catholics*  
5 *throughout Indiana regarding the mission and role of the*  
6 *Church in the public order, the political and democratic*  
7 *processes, and the issues and developments in public policy:*  
8 *Therefore,*

9 *Be it resolved by the House of Representatives*  
10 *of the General Assembly of the State of Indiana,*  
11 *the Senate concurring:*

12 SECTION 1. That the Indiana General Assembly recognizes the  
13 Indiana Catholic Conference on its 50th anniversary and the many  
14 contributions it has made to the people of Indiana.

15 SECTION 2. That the Principal Clerk of the House of  
16 Representatives transmit a copy of this resolution to the staff of the  
17 Indiana Catholic Conference.
