1	A CONCURRENT RESOLUTION congratulating Ivy Tech
2	Community College on its 60th anniversary.
3	Whereas, Ivy Tech Community College was founded on
4	March 15, 1963, and has grown to become the largest singly
5	accredited statewide community college in the United States;
6	Whereas, Ivy Tech has campuses throughout Indiana and also
7	serves thousands of students annually online;
8	Whereas, It serves as the state's engine of workforce
9	development, offering associate degrees, short-term certificate
10	programs, industry certifications, and training that aligns to
11	the needs of the community;
12	Whereas, The college provides seamless transfer to other
13	colleges and universities in Indiana, as well as out of state, for
14	a more affordable route to a bachelor's degree;
15	Whereas, Eight out of ten graduates of Ivy Tech graduate
16	without student debt, and 93% of graduates stay in Indiana to
17	work in industries that help drive the state's economy;
18	Whereas, From the nation's largest two-year nursing degree
19	program to tens of thousands of alumni who are nonprofit
20	leaders, manufacturing technicians, and small business owners,
21	the college shapes and positions talented leaders who
22	contribute to the state's thriving ecosystem;
23	Whereas, Ivy Tech contributes \$3.9 billion annually to
24	Indiana's economy, including a net impact of \$3.6 billion from



1	alumni alone, and awards more than 20,000 degrees and
2	certificates each year;
3	Whereas, With more than 40 locations across the state, no
4	one is closer, or more committed, to preparing students for the
5	careers that are part of tomorrow's economy than Ivy Tech
6	Community College; and
7	Whereas, From the classroom to the workplace, Ivy Tech is
8	putting the right tools and instruction in student hands so they
9	can be ready for tomorrow: Therefore,
10	Be it resolved by the House of Representatives
11	of the General Assembly of the State of Indiana,
12	the Senate concurring:
13	SECTION 1. That the Indiana General Assembly
14	congratulates Ivy Tech Community College on 60 years of
15	improving the lives of Hoosiers throughout Indiana.
16	SECTION 2. That the Principal Clerk of the House of
