## HOUSE CONCURRENT RESOLUTION No. 30

---

1       A CONCURRENT RESOLUTION petitioning the National Park  
2 Service to complete the Eastern Legacy Special Resource Study  
3 mandated by Congress in 2008 and to recommend inclusion of the  
4 Eastern Legacy sites, which include Indiana locations, in the Lewis and  
5 Clark National Historic Trail.

6       *Whereas, The Lewis and Clark National Historic Trail*  
7 *was established by Congress in 1978 and extended to the*  
8 *West from Wood River, Illinois, to the mouth of the Columbia*  
9 *River in Oregon and Washington;*

10       *Whereas, Section 343 of Public Law 110-229, enacted by*  
11 *the Congress of the United States in 2008, directed the*  
12 *National Park Service to conduct a Special Resources Study*  
13 *to assess the suitability and feasibility of extending the Lewis*  
14 *and Clark National Historic Trail by including the Eastern*  
15 *Legacy sites, the historic routes and sites in the East that*  
16 *were vital to the preparation and planning of the Lewis and*  
17 *Clark Corps of Discovery Expedition;*

18       *Whereas, Extending the Lewis and Clark National Historic*  
19 *Trail eastward fulfills the objectives of the National Trails*  
20 *System, established in 1968, to provide for the*  
21 *ever-increasing outdoor recreation needs of an expanding*  
22 *population and to promote the preservation of public access*  
23 *to, travel within, and enjoyment and appreciation of*  
24 *open-air, outdoor areas and historic resources of the nation;*

25       *Whereas, Stephen Ambrose wrote in his book, Undaunted*  
26 *Courage, "Lewis tied up at Clarksville and set off to meet his*  
27 *partner, who was living with his older brother, General*



1 *George Rogers Clark. When they shook hands, the Lewis and*  
 2 *Clark Expedition began.";*

3 *Whereas, Lewis and Clark recruited and enlisted the first*  
 4 *members of the Corps of Discovery before departing down*  
 5 *the Ohio River for the West from Clarksville on October 26,*  
 6 *1803;*

7 *Whereas, William Bratton of Waynetown, Montgomery*  
 8 *County, joined the Expedition near Clarksville and*  
 9 *completed the entire journey serving as a hunter, blacksmith,*  
 10 *and saltmaker; and*

11 *Whereas, Tourism is an important part of Indiana's*  
 12 *economy, and completing the Lewis and Clark National*  
 13 *Historic Trail to include Eastern Legacy sites such as*  
 14 *Indiana's Falls of the Ohio would greatly benefit the tourism*  
 15 *industry and overall economy of the state: Therefore,*

16 *Be it resolved by the House of Representatives*  
 17 *of the General Assembly of the State of Indiana,*  
 18 *the Senate concurring:*

19 SECTION 1. That the National Park Service in the United States  
 20 Department of the Interior is hereby urged and petitioned to  
 21 expeditiously complete, and provide to Congress, the Eastern Legacy  
 22 Special Resource Study.

23 SECTION 2. That the report of the Eastern Legacy Special Resource  
 24 Study shall include a recommendation that the Lewis and Clark  
 25 National Historic Trail be extended to the east by inclusion of the  
 26 historically significant eastern corridors of the Corps of Discovery  
 27 expedition for the period of 1803 through 1809.

28 SECTION 3. That the Principal Clerk of the House of  
 29 Representatives transmit a copy of this resolution to each member of  
 30 the Indiana Congressional delegation, Jonathan B. Jarvis, Director of  
 31 the National Park Service, and Cameron H. Sholly, Regional Director,  
 32 Midwest Region of the National Park Service.
