1           A CONCURRENT RESOLUTION memorializing Boone  
2 County Sheriff's Deputy Jacob M. Pickett.

3           *Whereas, Boone County Sheriff's Deputy Jacob M. Pickett*  
4 *was born in Columbus, Ohio, to Marlin and Rebecca Pickett on*  
5 *December 20, 1983;*

6           *Whereas, Deputy Pickett grew up with a passion for public*  
7 *safety and pursued a career in law enforcement after*  
8 *graduating from Brownsburg High School;*

9           *Whereas, Deputy Pickett graduated from the Marion County*  
10 *Sheriff's Office Training Academy in 2010. He displayed a*  
11 *passion for law enforcement and a devotion to public safety*  
12 *that earned him the recognition of his peers, and he received*  
13 *the County Correctional Officer of the Year Award in 2012 and*  
14 *the Sheriff's Jail Deputy of the Year Award in 2013;*

15           *Whereas, Deputy Pickett moved to the Tipton County Sheriff's*  
16 *Department in 2013 and graduated from the Indiana Law*  
17 *Enforcement Academy in 2014 with class 202 as a pistol*  
18 *expert;*

19           *Whereas, Deputy Pickett continued to build upon his skills as*  
20 *a law enforcement officer and in 2015 joined the Boone County*  
21 *Sheriff's Department, where he earned recognition as a Taser*  
22 *instructor, K-9 team leader, K-9 handler, and a member of the*  
23 *Fraternal Order of Police #110;*

24           *Whereas, Deputy Pickett and his K-9 partner, Brik, were in*  
25 *pursuit of a suspect on foot when Deputy Pickett was fatally*



1       *shot in the line of duty. He passed away on March 5, 2018;*

2               *Whereas, Deputy Pickett chose, in death as he had done so*  
3       *passionately in life, to help those in need as an organ donor;*  
4       *and*

5               *Whereas, Deputy Pickett was a selfless and devoted husband,*  
6       *father, son, and public safety officer who will be missed:*  
7       *Therefore,*

8                       *Be it resolved by the House of Representatives*  
9                       *of the General Assembly of the State of Indiana,*  
10                      *the Senate concurring:*

11           SECTION 1. That the Indiana General Assembly honors the  
12       memory of Boone County Sheriff's Deputy Jacob M. Pickett for  
13       protecting the lives of all Hoosiers.

14           SECTION 2. That the Principal Clerk of the House of  
15       Representatives transmit copies of this resolution to the family
